The instant application (“Application”) seeks Federal Communications Commission (“FCC”) consent to the assignment (“Assignment”) of FM radio station WVKM(FM), Matewan, West Virginia, Facility ID No. 67039 (“Station”) from Three States Broadcasting Company, Inc. to West Virginia Educational Broadcast Authority, Inc. (“WVEBA”). A copy of the Asset Purchase Agreement for the Assignment is attached to the Application.

Parties to the Application. WVEBA is a West Virginia non-profit corporation and the proposed licensee of the Station. WVEBA was established by the West Virginia Legislature in 1963 as a public benefit corporation on behalf of noncommercial educational radio, television and related media as it may consider to be in the best interest of the state. WVEBA holds the licenses for all the West Virginia Public Radio and West Virginia PBS stations in the state. The members and officers of WVEBA are as follows:

Pursuant to Section 73.3555(f) of the FCC's rules, the multiple ownership and cross-ownership rules ("Ownership Rules") do not apply to non-commercial educational FM or non-commercial educational TV stations. Upon consummation of the Assignment, the Station will be the *sole* broadcast station owned by WVEBA that is subject to the Ownership Rules and, thus, this Application complies with the Ownership Rules.
