**ORDER DIRECTING JOINT
ADMINISTRATION OF DEBTORS' RELATED CHAPTER 11 CASES**

Upon the Debtors'¹ Motion for an order pursuant to Section 105 of Title 11 of the United States Code, 11 U.S.C. §§ 101-1532 (as amended, the "Bankruptcy Code") and Rule 1015(b) of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules") directing the joint administration of the Debtors' related Chapter 11 cases for procedural purposes only, as more fully described in the Motion; and upon consideration of the Declaration of James A. Morgan, Pursuant to Rule 1007-2 of the Local Bankruptcy Rules of the Southern District of New York (the "Morgan Declaration"); and the Court having jurisdiction pursuant to Sections 157 and 1334 of Title 28 of the United States Code to consider the Motion and the relief requested therein; and the Debtors' chapter 11 cases having been automatically referred to this Court by the Standing Order of the District Court for the Southern District of New York, dated July 10, 1984 (Ward, Acting Chief Judge); and venue being proper in this Court pursuant to Sections 1408 and 1409 of title 28 of the United States Code; and due and proper notice of the Motion having been provided; and it appearing that no other or further notice need be provided; and the Court having determined that the relief sought in the Motion is in the best interests of the Debtors' estates, their creditors, and all parties in interest; and the Court having heard the evidence and statements of counsel regarding the Motion at the Hearing before the Court (the "Hearing"); and the Court having determined that the legal and factual bases set forth in the Motion, at the Hearing and in the Morgan Declaration establish just cause for the relief granted herein, and after due deliberation and sufficient cause appearing therefor.
