Section II, Question 4

Allur-Kansas City, Inc. (“Allur”), licensee of KMJK(FM), is wholly-owned by Syndicated Communications Venture Partners II, L.P. (“Syncom II”), a limited partnership organized in Delaware. The General Partner of Syncom II is Wilkins & Jones, L.P. (“W&J”), a limited partnership organized in Delaware. W & J holds 100% voting interest and 1% of the equity in Syncom II. The remaining equity is held by passive non-attributable limited partners.

The principals of W&J are Herbert P. Wilkins, Sr., who is the Managing General Partner and holds a 45.9% ownership interest; Terry L. Jones, a General Partner and holds a 31.5% ownership interest; and Duane C. McKnight, a General Partner and holds a 12.6% ownership interest. The remaining 10.0% ownership interest is held by K Street Ventures Associates, Inc., a Delaware corporation, which is 100% owned by Syndicated Communications, Inc. (“Syncom I”), a Delaware corporation.

All of the principals in Syncom II also have common ownership interests in Syncom I, Syndicated Communications Venture Partners III, L.P. (“Syncom III”), and WJM Partners III, LP, the General Partner of Syncom III, both limited partnerships organized in Delaware.

Syncom II wholly owns Syncom Radio Corporation, the licensee of KCHZ(FM), Ottawa, KS, Facility ID #33332. Syncom III holds 15% ownership interests in Diamond Radio, Inc., the licensee of KBMB(FM), Sacramento, CA, Facility ID #20435.

Syncom II also holds a non-attributable (less than 5% voting) interest in Radio One, Inc. (“ROI”). Although Syncom II’s ownership interest is non-attributable, Mr. Jones serves on the Board of Directors for ROI, the corporate parent of the following:
