277C2

White Park Broadcasting proposes to modify its existing construction permit (BNPH-20060310AAL) to upgrade to 277C2 and change the City of License for KHNA to Warren AFB WY. As shown in *Figure 1*, the proposed transmitter location meets spacing requirements specified in 47 C.F.R. 73.207 with 2 exceptions explained below. This location is also mutually exclusive with KHNA's current Construction Permit. There are no major obstacles between the proposed site and any portion of Warren AFB WY, and the entire area of Warren AFB will easily be encompassed by the predicted 70 dBu contour.

One record in the current CDBS shows the proposed operation to be prohibited short-spaced to an allotment for 277C2 allocated to Cheyenne WY. The Commission's Report and Order RM-10960 released November 29, 2006, specifies "the Table of Allotments to reflect only vacant allotments that do not correspond to an authorized station or reserved assignment." The table of allotments (Appendix A) as published in this R & O does not contain any open allotment for Cheyenne. This allotment was part of RM-bg-103 filed by Mountain States Radio in 2004 (pre-dating the R & O) and was denied by the Commission in September 2004. Thus this record is an error and can be disregarded and there is no prohibited short-spacing.

The second and third records listed are a pending application for KHNA that this application will supersede.

The proposed operation requests to utilize contour protection under Section 73.215 toward KRFK, Denver CO. Compliance with section 73.215 is documented in exhibit 30.

All other records indicate minimum spacing as required by section 73.207 have been met.

Figure 1 demonstrates compliance with Section 73.207 with the explanations noted above.
