Dear Licensee:

AMFM Broadcasting Licenses, LLC (“AMFM”) is hereby notified of the modification of its license for KDWB-FM, Richfield, MN, to specify operation on Channel 267C0.

On January 10, 2019, Q Media Properties, LLC (“Q Media”), licensee of station WCMP-FM in Pine City, MN, filed a minor change construction permit application. Q Media’s application proposed that KDWB-FM’s license be modified to specify Class C0 in lieu of Class C in accordance with the procedures set forth in Note 4 of 47 C.F.R. Section 73.3573.¹ Accordingly, by staff letter dated April 15, 2019, KDWB-FM was directed to show cause why its license should not be modified to specify Channel 267C0 in lieu of Channel 267C. The letter stated that failure to respond to this letter within thirty days will result in the automatic downgrade of KDWB-FM. As of the date of this letter, KDWB-FM has failed to file a response to the April 15, 2019 letter, and thus, has consented to the downgrade.

Accordingly, pursuant to the authority found in Sections 4(i), 5(c)(1), 303, and 307(b) of the

Communications Act of 1934, as amended, and Sections 0.61, 0.204(b), 0.283, 1.420, 73.203(b), and 73.3573 of the Commission's Rules, as amended, IT IS ORDERED, that as of the effective date of this letter, the FM Assignment for Richfield, MN, IS MODIFIED, as follows:
