Mr. Hashemzadeh,

I just wanted to bring the above referenced STA request to your attention and provide an explanation. K59CI filed a displacement application for operation on in-core Channel 27 (FCC File No. BDISDTT-20090824ACI). Verizon, however, is preparing for 700 MHz operations that would cause actual displacement of the current Channel 59 operations. K59CI understands that the pending displacement application must undergo Mexican review, so it accordingly has filed the above-referenced STA request to permit operation on Channel 27 until such time as the Commission can complete processing of the displacement application.
