TECHNICAL STATEMENT

1. This technical statement and attached exhibits were prepared on behalf of Positive Alternate Radio, Inc. ("PAR"), proposed assignee of WTTX-FM, Channel 296A, Appomattox, Virginia.¹ Principals of PAR have attributable interest in WKGM, Inc., licensee of WBNN-FM, Channel 287A, Dillwyn, Virginia.² As indicated on Exhibit #1, the city grade contour of WTTX-FM does not overlap with the city grade contour of WBNN-FM. As such, there are no multiple ownership issues involved in PAR's acquisition of WTTX-FM.

2. The foregoing technical statement was prepared on behalf of Positive Alternative Radio, Inc. by Graham Brock, Inc., its Technical Consultants. All information contained herein is true and accurate to the best of our belief and knowledge. All data relating to AM and FM facilities was extracted from the CDBS database. - 1) PAR is a non-profit company and is the licensee of numerous non-commercial stations. WTTX-FM is presently a commercial FM facility, which PAR proposes to operate as a non-commercial facility. However, principals of PAR also have attributable interests in companies which hold commercial broadcasting facilities.
- 2) WBNN-FM is the closest commercial station in proximity to WTTX-FM.





His qualifications are a matter of record before the Federal Communications Commission. He has been active in Broadcast Engineering since 1979.


