**Complaint of Interference by FM Translator Station to Full-
Service Station**

Dear Ms. Dortch:

We are counsel to Gow Media, LLC ("Gow"). Gow is the licensee of full-service FM Station KFNC(FM) (97.5 MHz), Mont Belvieu, Texas (FIN: 52407).

Gow is hereby filing this Complaint against FM Translator Station K248BD, Hockley, Texas (the "Translator Station" or K248BD), which is licensed to Aleluya Broadcasting Network ("ABN") and operates, on a co-channel basis, on Output Channel 248 (97.5 MHz).

This Complaint arises from what Gow submits is a clear and uncontested violation of Section 74.1203(a) of the Commission's Rules. That provision requires that an FM translator "will not be permitted to continue to operate if it causes any actual interference to: (1) the transmission of any authorized broadcast station...." KFNC has, since the Translator Station commenced operations, been receiving actual interference from K248BD and has no recourse but to bring its concerns to the Commission's attention for prompt resolution and remediation.

The Translator Station has operated on Output Channel 248. However, the Translator Station has served the community of Hemphill, Texas, far from the Houston area, for more than ten years, with a 40 watt output signal at the low height of five meters above ground level.¹ In File No. BPFT-20160610AAA, ABN applied to modify the transmitter site to a location closer to Houston, serving Hockley, Texas, on a multi-user tower with a significantly increased level of service: 240 watts output at 136 meters.

Gow has been monitoring the status of K248BD in the Commission's data base in order to determine, upon commencement of operations, whether the Translator Station would cause interference to KFNC. It recently became aware of interference on Channel 248 that appears to result from the relocated operations of K248BD. However, Gow's efforts to confirm this have been frustrated by the absence of a license to cover application (FCC Form 350) on file for K248BD in File No. BPFT-20160610AAA. In the absence of such an application, which is required by Section 74.14(a) of the Commission's Rules, Gow is not certain as to what type of antenna is being used and where the antenna is actually located. The failure to file a license to cover application at the same time that the Translator Station commenced operations, alone, is reason for action to be taken by the Commission.

In that FM translator stations are secondary services, they have no absolute right to continue to broadcast under any circumstances. Section 74.1203(a) teaches us that FM translator stations must protect full-service stations. *The Association for Community Education, Inc.*, 19 FCC Rcd 12682 (2004). When it is evidenced, by listener communications or otherwise, that an FM translator is interfering with a full-service station, the FM translator licensee must shut down its operations or the Commission will shut down the FM translator in order to protect the full-service station, as provided for in Sections 74.1203(e) and 74.1232(h). *Id.* at 12688.


Attached hereto, as Exhibit A, are the Declarations of Gow listeners who have been detrimentally affected by the interference being suffered. In addition, Gow is aware of at least one advertiser that has withdrawn its business from KFNC owing to the inability to reach listeners who are impacted by the interference. This is causing harm to KFNC that cannot be easily or quickly resolved and gets worse by the day.

Considering these factors, Gow requests that the Commission issue a Section 74.1203(e) notice to ABN mandating that the operation of Station K248BD, from any site other than the currently licensed one, "be suspended within three minutes and shall not be resumed until the interference has been eliminated or it can be demonstrated that the interference is not due to spurious emissions by the FM translator."
