Re: Request for Waiver of Construction Deadline
Construction Permit (File No. BNPFT-20130828ADF)

Dear Ms. Dortch:

Kent State University ("Kent State") and Radio License Holding CBC, LLC ("RLH") filed an assignment application with the FCC on October 13, 2016 (File No. BAPFT-20161013AAN) requesting Commission consent to assign the construction permit for unbuilt FM translator station W225BZ, Ashland, Ohio (Facility ID 146827) ("Construction Permit") from Kent State to RLH. With the consent of Kent State, RLH filed a minor change application on October 17, 2016 (File No. BMPFT-20161017ABK) seeking authorization to move W225BZ from Ashland, Ohio to Erie, Pennsylvania and rebroadcast primary station WRJE(AM), Erie, Pennsylvania (Facility ID 32982). Upon a grant of the modification application, RLH will promptly construct the modified translator station and initiate broadcast operations.

The Construction Permit currently is scheduled to expire on January 6, 2017. RLH respectfully requests a waiver of the construction deadline set forth in the Construction Permit pursuant to footnote 36 of the Commission's *Revitalization of the AM Radio Service*, First Report and Order, Further Notice of Proposed Rule Making, and Notice of Inquiry, 30 FCC Rcd 12145, ¶15 (2015), for six (6) months from the later of the consummation of the assignment of the Construction Permit, or the grant of the above-referenced modification application.

RLH certifies that no party to this request is subject to a denial of federal benefits pursuant to Section 5301 of the Anti-Drug Abuse Act of 1988, 21 U.S.C. Section 862.
