

Galaxy Syracuse Licensee LLC (“Galaxy Syracuse”) is the licensee of the following full-power broadcast stations:

WTLA(AM)	54546	Syracuse, NY
WTKW(FM)	22234	Bridgeport, NY
WTKV(FM)	24131	Minetto, NY

The communities of licenses of all of these stations except for WKRH(FM) are located in counties that are part of the Syracuse, New York Nielsen Audio metro. In March 2015, Galaxy Syracuse completed construction of a new transmitter site to implement a community of license change for Station WKRH(FM) from Minetto to Fair Haven, New York and filed a license to cover application (File No. BLH-20150324AAS). Fair Haven is located in Cayuga County, which is not assigned to any Nielsen Audio metro.

As indicated on the BIA/Kelsey Media Access Pro FCC Geographic Market report for the Syracuse, New York Nielsen Audio metro attached hereto, WKRH is not considered home to the metro¹. The report shows that there are a total of 41 full-power commercial and non-commercial stations in the Syracuse metro. Section 73.3555 (a)(1)(ii) of the Commission’s rules provides that in markets with 30 to 44 full-power commercial and non-commercial radio stations, a single entity may not have a cognizable interest in more than seven commercial radio stations in total and not more than four stations in the same service. Galaxy Syracuse is currently the licensee of three AM and three FM stations that are included in the Syracuse market on the BIA/Kelsey report. Upon grant of the instant application, Galaxy Syracuse would have an interest in four FM stations and three AM stations, as permitted under the rule.

Because Fair Haven, NY is not part of the Syracuse metro, in accordance with Commission requirements, a contour-based multiple ownership analysis was prepared for the above-listed stations and Station WZUN(FM). The principal community contours of WKRH(FM) and WZUN(FM) do not overlap. As shown in the Technical Statement prepared by duTreil, Lundin & Rackley, Inc. attached hereto, the principal community contour of

¹ Station WKHR simulcasts the programming of Station WKRL(FM), licensed to North Syracuse. However, Galaxy has elected **not** to have the ratings of these stations aggregated as part of Total Line Reporting. The ratings of each station are reported individually.

WKRH(FM) has common overlap with the principal community contours of Stations WSCP(AM), WSGO(AM) and WTKV(FM). Accordingly, these four radio stations are deemed to be a single radio market. The attached Technical Statement shows the composite principal community contour for the contour-based market formed by these four radio stations. The exhibit also includes a tabulation of 20 radio stations whose transmitter sites are located within this composite contour. Galaxy Syracuse's ownership of four stations in this contour-based radio market therefore is consistent with Section 73.3555(a)(1)(iii) of the Commission's rules which provides that in markets with between 15 and 29 full-power commercial and non-commercial stations, an entity may have an attributable interest in up to six stations.

Because the WKRH community of license was changed from Minetto, which is in the Syracuse metro, to Fair Haven, which is not part of any Nielsen Audio metro, Galaxy should not be subject to the two-year waiting period for the removal of Station WKRH from the Syracuse metro and the instant application permitting Galaxy to acquire Station WZUN(FM) should be granted. In its decision in *Alan G. Moskowitz, Esq.*, the Bureau stated specifically that a licensee demonstrating compliance with the local radio ownership rule "may rely upon the removal of a station from BIA's list of home stations in a Metro, without a two-year waiting period, when the exclusion results from an FCC approved change in the community of license from within a Metro to outside the Metro." 28 FCC Rcd 16489, 16491 (2013). In addition, Worksheet #3 of the instructions to FCC Form 314 states specifically that an applicant may rely on the removal of a station from a market as reflected in a BIA Kelsey report without waiting two years if "the exclusion results from an FCC-approved change in the community of license of a station from within the Metro to outside the Metro."

This radio multiple ownership analysis was prepared on behalf of Galaxy Syracuse Licensee LLC (herein “Galaxy”) concerning the ownership of the stations listed below.

As Fair Haven, NY is not part of the Syracuse metro, in accordance with Commission requirements outlined in Section 73.3555, a contour based multiple ownership analysis was prepared for the above listed stations. Only those stations involved in contour overlap with WKRH(FM) have been considered. The principal community contours (3.16 mV/m for FM stations, 5 mV/m for AM stations) of the pertinent stations are depicted on a map included herein as Figure 1.

Radio Market

The “radio market” applicable to common ownership of the subject stations is defined as the area encompassed by the mutually overlapping principal

community contours of the stations proposed to be commonly owned.¹ There is one “radio market” defined for analysis under the Commission’s Rules. The table below lists the defined market:

Count of Stations in Defined Market

The number of other radio stations in a “radio market” is determined by counting the operating stations having principal community contours that intersect the principal community contours which define the radio market, plus the subject stations that are co-owned. Only those stations located within 92 kilometers of the perimeter of the mutual overlap area of the respective defined market area were employed in the count of the stations. Commonly controlled stations were not considered in the count of stations in the defined markets. The results of the analysis are tabulated below:

Figure 2 is a tabulation of the radio stations identified in the defined radio markets tabulated above. It is noted that the tabulation is not a complete list of all of the other stations in the market, but rather enough stations to show compliance with the FCC’s radio multiple ownership rules. Only known licensed, operating stations were employed for the study.

Distances to the AM coverage contours were predicted using the antenna patterns as identified in the Commission’s AM database and the appropriate Ground Wave Field Strength versus Distance Graph of 47 CFR 73.184. Ground conductivity data were obtained from FCC Figure M3. Distances to the FM contours were determined based on the method of 47 CFR 73.313. Terrain data was derived from the N.G.D.C. 30-second computer database for each of the FM stations using radials evenly-spaced every 5 degrees of azimuth.

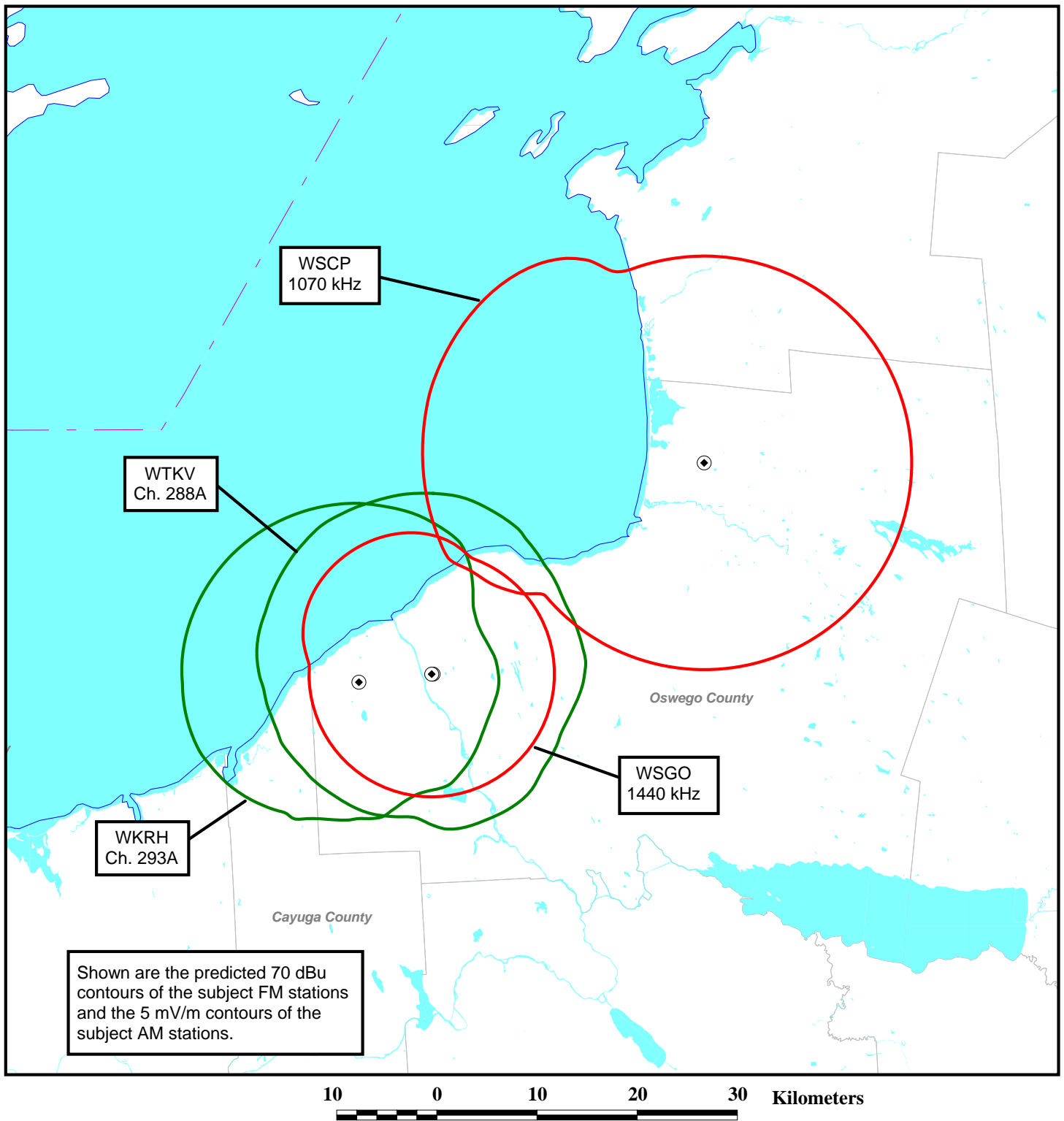
Based on the above, it is concluded that the Galaxy will be in compliance with the Section 73.3555(a) of the FCC Rules using the interim contour method.
