

## EXHIBIT 17

### Family Relationships

William M. McClatchey, Jr. and Donna C. McClatchey are husband and wife.

Ms. McClatchey has passive interests in the following radio stations in the Raleigh-Durham Arbitron Metro:

- Ms. McClatchey owns a non-attributable 10 percent non-voting interest in First State Communications, Inc., the licensee of WPTF(AM), Raleigh, N.C. (Facility ID Number 21630). Ms. McClatchey's ownership of this company is as a passive investor. She is not involved in the management or operation of the company's broadcast station.
- Ms. McClatchey owns a 20 percent membership interest in Triangle Broadcast Associates, LLC, the licensee of WDOX(AM), Raleigh, N.C. (Facility ID Number 61698), and WCLY(AM), Raleigh, N.C. (Facility ID Number 51262).<sup>1</sup> Ms. McClatchey's ownership of this company is as a passive investor. She is not involved in the management or operation of the company's broadcast stations.
- Ms. McClatchey owns a 20 percent membership interest in WWMY, LLC, the current licensee of WWMY(FM), Raleigh, N.C. (Facility ID Number 4841). Ms. McClatchey's ownership of this company is as a passive investor. She is not involved in the management or operation of the company's broadcast station.

In FCC File No. BALH-20091001AGI, WWMY, LLC proposes the assignment of WWMY(FM) to WRBZ, LLC. In FCC File No. BAL-20091001AFH, WWMY, LLC is the proposed assignee of WRBZ(AM), Raleigh, N.C. (Facility ID Number 888). These proposed assignments are in connection with an exchange transaction.

Upon consummation of these assignments, WWMY, LLC will be the licensee of only WRBZ(AM). Ms. McClatchey's passive ownership in WWMY, LLC will not change and Ms. McClatchey will remain uninvolved in the management or operation of the company's broadcast station.

Mr. McClatchey has an interest in the following radio station in the Raleigh-Durham Arbitron Metro:

- Mr. McClatchey owns 100 percent of WRBZ, LLC, the current licensee of WRBZ(AM).

In FCC File No. BAL-20091001AFH, WRBZ, LLC proposes the assignment of WRBZ(AM) to WWMY, LLC. In FCC File No. BALH-20091001AGI, WRBZ, LLC is the proposed assignee of WWMY(FM), Raleigh, N.C. These proposed assignments are in connection with an exchange transaction.

Upon consummation of these assignments, WRBZ, LLC will be the licensee of only WWMY(FM).

Notwithstanding Mr. McClatchey's and Ms. McClatchey's spousal relationship, "the media interests of one spouse will not be presumptively attributed to the other solely on the basis of marital status." *Sevier Valley Broadcasting, Inc.*, 10 FCC Rcd 9795 (1995); *Policy Statement, Clarification of Commission's Policies Regarding Spousal Attribution*, 7 FCC Rcd 1920 (1992).

In applying the *Sevier Valley Broadcasting, Inc.* factors to the McClatchey spousal relationship, the specific facts and circumstances in this case demonstrate that Mr. McClatchey's and Ms. McClatchey's broadcast interests will be independent and not subject to common influence or control by the other.

Following is an analysis of the *Sevier Valley Broadcasting, Inc.* factors, as itemized in Worksheet #3B of the instructions to FCC Form 314, with respect to the McClatchey spousal relationship:

1. *Has the family member who is not included as a party to the application been involved in negotiations with the licensee/permittee for the acquisition/construction of any of the station(s) to be assigned?*

Ms. McClatchey has not been involved in negotiations on behalf of WRBZ, LLC, for the acquisition of WWMY(FM).

Mr. McClatchey has not been involved in negotiations on behalf of WWMY, LLC, for the acquisition of WRBZ(AM).

2. *Has the family member who is not included as a party to the application provided financing or otherwise been involved in the process of making financial arrangements for the acquisition/construction of any of the stations(s) to be assigned?*

Ms. McClatchey is not providing financing to WRBZ, LLC, for the acquisition of WWMY(FM). Rather, there is no financing, as the transaction is part of an exchange transaction. As approved by the Commission in connection with FCC File No. BAL-20041118ACX, WRBZ, LLC's bank loan is partially secured by Ms. McClatchey's pledge of her minority interests in certain companies.

Mr. McClatchey is not providing financing or otherwise involved in the process of making financial arrangements for WWMY, LLC's acquisition of WRBZ(AM). Again, there is no financing, as the transaction is part of an exchange transaction.

3. *Is this the first broadcast ownership interest of the family member who is party to the application?*

Ms. McClatchey's interest in WRBZ(AM) would not be her first broadcast ownership interest, as set forth above. Nonetheless, as with her other broadcast interests, her interest in WRBZ(AM) will be as a minority passive investor, and she will not be involved in the management or operation of WRBZ(AM).

Mr. McClatchey's interest in WWMY(FM) would not be his first broadcast ownership interest. Mr. McClatchey has independently owned, managed and operated WRBZ(AM) since February 2005, and previously, Mr. McClatchey independently owned, managed and operated WKVS(FM), WJRI(AM), and WKGX(AM), Lenoir, North Carolina. Prior to acquiring the Lenoir stations, Mr. McClatchey, who has a masters in business administration, worked for approximately 4 years in investment banking, including 2 years with a media investing group where he was involved in radio station transactions.

4. *Are the family members involved together in the management or operation of any other media interests located in other markets?*

Ms. McClatchey and Mr. McClatchey are not involved in the management or operation of any of each other's media interests. In fact, as indicated above, Ms. McClatchey is not even involved in the management or operation of her companies in which she holds minority interests.

5. *Are there any agreements, arrangements or understandings, either written or oral, between the family members with same-market media interests for the participation of one family member in the financial affairs, commercial practices, programming, or employment practices of the other family member's media entity? Consider, for example, joint sales agreements, local marketing agreements, and arrangements to share facilities or personnel?*

There are no agreements, arrangements or understandings, either written or oral, or express or implied, between Mr. McClatchey and Ms. McClatchey, for the participation of either in the financial affairs, commercial practices, programming, employment practices, or personnel decisions, of the others' same-market media interests, nor do any of these family members intend to enter into such agreements. Neither Mr. McClatchey nor Ms. McClatchey intends to share facilities or personnel or enter into attributable joint sales agreements or local marketing agreements with the other's stations.

The above factors demonstrate the independence of Mr. McClatchey's proposed ownership of WWMY(FM) and Ms. McClatchey's proposed minority interest in WRBZ(AM). Ms. McClatchey has no involvement in Mr. McClatchey's broadcast interests, and Mr. McClatchey has no involvement in the stations in which Ms. McClatchey has passive ownership interests.

Accordingly, the instant application does not present an issue under the Commission's policies relating to media interests of immediate family members.
