Dear Applicants:

This letter is in reference to the above-captioned contingent minor change applications.

An engineering study of the proposed directional antenna for KLKA(FM), reveals that it is in violation of 47 C.F.R. § 73.510(a). Section 73.510(a) states that noncommercial educational stations must comply with 47 C.F.R. § 73.316(b). Specifically, the proposed radiation pattern of the application varies by more than 2 dB per 10 degrees. It is necessary to note that this violation occurs in the direction of short-spaced stations and the directional antenna is necessary to prevent any prohibited overlap. Pursuant to 47 C.F.R. § 73.316(b)(2), directional antennas used to protect short-spaced stations that have a radiation pattern which varies more than 2 dB per 10 degrees of azimuth will not be authorized.

In light of the above, Application BMPED-20070803ACY is unacceptable for filing pursuant to 47 C.F.R. § 73.3566(a) and IS HEREBY DISMISSED. We note that the application was filed as part of a contingent application group with BMPED-20070803ACM, BPED-20070803ACZ, and BPED-20070803ACO. Pursuant to 47 CFR Section 73.3517(e), dismissal of any one of the related applications as unacceptable will result in the dismissal of all the related applications. Therefore, applications BMPED-20070803ACM, BPED-20070803ACZ, and BPED-20070803ACO ARE HEREBY DISMISSED. These actions are taken pursuant to 47 CFR Section 0.283.
