

Exhibit 14 – Parties to the Application

This application requests Commission consent for the transfer of control of Lamco Communications, Inc. (“Lamco”), from the Shareholders of Lamco to BlueStone TV Holdings Inc. (“BlueStone Holdings”). The transfer of control will occur as the result of a merger of Lamco and BlueStone Merger Co., a wholly owned subsidiary of BlueStone Holdings. After the merger, Lamco will be the surviving entity as a wholly owned subsidiary of BlueStone Holdings.
