

ATTACHMENT TO EXHIBIT 2

Goddard College Corporation (“GCC”), licensee of Noncommercial Educational FM Stations WGDR, Plainfield, Vermont, and WGDH, Hardwick, Vermont, is a non-stock, non-profit organization. GCC is filing this application to obtain Commission consent to new members of its Board of Directors.

The selection of GCC’s new Board of Directors took place pursuant to its Articles of Incorporation and By-Laws. The resulting transfer of control occurred gradually, over time, through routine changes in board membership.

This application is intended to bring the station into compliance with the requirement to obtain FCC approval of the board after 50% of the members of the board of directors have changed. The Board Members during each of the years from 2005, when the Commission last granted an application for transfer of control of the licensee (BTCED-20051220AOI, granted December 28, 2005), are set forth in the chart below.

No consideration or thing of value is being given in exchange for the interests being transferred. All Board Members are U.S. citizens. Each Board Member has one vote except where indicated as Ex Officio (“EO”). None have any interests in any mass media other than WGDR and WGDH.
