Dear Applicants:

The staff has under consideration: (1) KVVA-FM's above-captioned contingent minor change application BPH-20100817ABA to change the licensed facilities of KVVA from Apache Junction, AZ to Sun Lakes, AZ; (2) KDVA's above-captioned contingent minor change application BPH-20100817AAX to change channels from Channel 295A to Channel 294A; (3) the September 2, 2010 Informal Objection and Request for Dismissal filed by Able Radio Corporation ("Able"); and (4) all other related pleadings.

The KVVA application was filed more than three years after an application BNPH-20070403ACO for a new commercial FM facility to serve Aguila, AZ, and conflicted with the earlier filed application. Under the Commission's processing system for FM commercial applications, applications are processed on a first come / first served basis. Later filed applications are "held in queue" behind the first-filed or lead application.¹ If the lead application is granted, the queue is dissolved and the queue applications are dismissed; if the lead application is dismissed, then the first queue application (the application filed closest in time after the lead application) is processed. In the present instance, the staff granted the lead application BNPH-20070403ACO on November 28, 2011. As a result, the first come/first served queue is dissolved and KVVA's application, as part of that queue, will be dismissed.

In light of the above, Application BPH-20100817ABA IS HEREBY DISMISSED. Furthermore, the Informal Objection and Request for Dismissal file by Able and all other related pleadings ARE HEREBY DISMISSED AS MOOT. We note that KVVA's application was filed as part of a contingent application group with KDVA's above-captioned application BPH-20100817AAX. Pursuant to 47 C.F.R. Section 73.3517(e), dismissal of any one of the related applications will result in the dismissal of all the related applications. Therefore, Application BPH-20100817AAX IS HEREBY DISMISSED. These actions are taken pursuant to 47 C.F.R. Section 0.283.
