

**EXHIBIT 10**  
**DESCRIPTION OF TRANSACTION**

This application seeks Commission consent, *nunc pro tunc*, to the *pro forma* transfer of control of Marri Broadcasting, L.P. (“Marri”), the licensee of WZVI(TV), Charlotte Amalie, USVI (Fac. ID No. 83270), resulting from a reorganization of Marri’s sole general partner, Marri Broadcasting Corporation (“MBC”). As Marri’s sole general partner, MBC has 100% voting control and sole management authority over Marri.<sup>1</sup>

Since the filing of its 1996 application for a construction permit to build WZVI(TV), Marri has been controlled by members of the Harry E. Figgie, Jr. family. At certain junctures, particularly following the death of Harry E. Figgie, III in 1999 and of Harry E. Figgie, Jr., earlier this year, the surviving family members have adjusted the nature of their interests in Marri for tax and estate planning purposes. At all times, however, ultimate control of Marri has remained in the Figgie family.

In granting Marri an initial construction permit for WZVI(TV) in FCC File No. BPCT-19960718KQ, the Commission approved of the structure depicted in Figure 1, which vested control of Marri in MBC and, ultimately, MBC’s five shareholders: Harry E. Figgie, III (25%); Matthew P. Figgie (25%); Harry E. Figgie, Jr., Trustee of the Harry E. Figgie Trust Agreement, dated July 15, 1976, as modified (the “Harry E. Figgie, Jr. Trust”) (5%); Nancy F. Figgie, Trustee under Trust Agreement September 7, 1976, as modified (the “Nancy F. Figgie Trust”) (20%); and Mark P. Figgie (25%). Harry E. Figgie, Jr., and Nancy F. Figgie are husband and wife and are the parents of Harry E. Figgie, III, Matthew P. Figgie, and Mark P. Figgie.

In 1999, Harry E. Figgie, III, died, and on February 12, 2002 his shares of MBC were redeemed, which resulted in a reallocation of the voting and economic interests of MBC’s remaining shareholders. On June 22, 2005, Matthew P. Figgie and Mark P. Figgie placed their interests in MBC into existing trusts – the Matthew P. Figgie Declaration of Trust dated October 20, 1985, as modified (the “Matthew P. Figgie Trust”), and the Mark P. Figgie Declaration of Trust dated June 19, 1986, as modified (the “Mark P. Figgie Trust”), respectively – that were formed for estate, tax, and other family planning purposes.<sup>2</sup> In July 2009, Harry E. Figgie, Jr., died, and Nancy F. Figgie and Matthew P. Figgie succeeded him as Co-Trustees under the Harry E. Figgie, Jr. Trust.

<sup>1</sup> Atlas News and Information Services, Inc. (“Atlas”), has a 20% non-voting limited partnership interest in Marri. David and Claudia Lampel each have a 50% voting and economic interest in Atlas.

<sup>2</sup> Matthew P. Figgie is the Trustee of the Matthew P. Figgie Trust, and Mark P. Figgie is the Trustee of the Mark P. Figgie Trust. Since their ownership interests in MBC simply shifted from the brothers, as individuals, to the brothers, as trustees of their respective trusts, the need for FCC consent was overlooked.

The changes described herein are *pro forma*, inasmuch as control of Marri, through MBC, still rests with the surviving members of the Figgie family, and no individual shareholder of MBC has acquired a controlling interest in the company.





Figure 2: Current Structure of Marri Broadcasting, L.P.

Marri's current ownership structure is depicted graphically in Figure 2 and in the following tables:
