This Technical Exhibit is submitted in support of an **APPLICATION FOR CONSTRUCTION PERMIT FOR A LOW POWER FM BROADCAST STATION** on behalf of PCRA, Inc., McPherson, KS for a facility to serve the city of McPherson, KS on FM Channel 294.

Channel Availability

The following study reveals that the requested channel meets all distance separation requirements relative to nearby co-channel and 1st, and 2nd adjacent channel licensed facilities, allotments, or applications (of record as of August 28, 2013). See Figure 1.

Input protection of any relevant FM Translators or Boosters

The closest FM translator authorization is K205CR, which is 6.25 kilometers away from the proposed facility (see Figure 2). K205CR translates the signal of primary station KYFW-FM, Channel 202, Wichita, KS. Since the proposed facility will not occupy a channel that is third adjacent to the primary station of translator

K204CR, and is located more than two miles from the closest FM translator, the Application complies with the provisions of 73.827(a)

The proposed facility will be located on an FAA approved, FCC registered tower, ASR # 1038591.
