

## **TRANSLATOR LICENSE TRANSFER AGREEMENT**

THIS Translator License Transfer Agreement ("Agreement") is made as of January 16, 2007, between Idaho Public Television ("IdahoPTV") and Central Idaho TV, Inc. ("Central Idaho").

WHEREAS, Central Idaho has heretofore held a translator license for the purpose of serving the communities located in and around Grangeville, Idaho;

WHEREAS, Central Idaho desires to transfer said translator license to Idaho PTV and Idaho PTV is willing to accept said translator license and become the licensee with respect to said translator license;

NOW, THEREFORE, in consideration of the mutual promises, conditions, and covenants set forth herein, the parties agree as follows:

- A. Central Idaho agrees to devise to IdahoPTV and IdahoPTV agrees to acquire from Central Idaho that certain translator license K59BA assigned to the Grangeville, Idaho community.
- B. The parties agree to comply with and take such action consistent with all applicable Federal Communications Commission ("FCC") laws, regulations and procedures associated with the transfer and continued operation of said translator license K59BA.
- C. The parties acknowledge and expect that this Agreement will be an exhibit to required FCC documentation in effectuating the transfer of said translator license K59BA to Idaho PTV.
- D. Upon performance of this Agreement and contingent on FCC approval and completion of FCC procedures required for effectuation of translator license K59BA transfer to Idaho PTV, Idaho PTV will acquire title to and full ownership of translator license K59BA and will assume all operation and maintenance responsibilities related thereto in its capacity as new licensee of translator license K59BA.

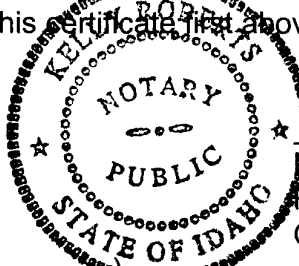

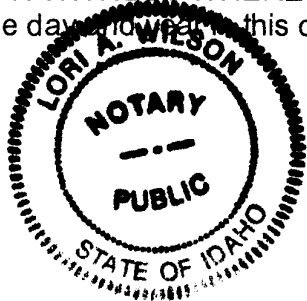
