

**EXHIBIT 8**

**Character Issues**

The licensee, Sunbelt Television, Inc. (“Sunbelt”), has been involved in certain FCC proceedings where allegations were made against Sunbelt that might be characterized as raising character issues. All but one of these proceedings have been concluded and no adverse findings have been made by the FCC against Sunbelt involving character issues and no character issues regarding Sunbelt have been designated by the FCC for further consideration or action. While it is not clear that disclosure is required, disclosure is being made out of an abundance of caution. Proceedings where such allegations were made against Sunbelt include the following:

**1. Application for Voluntary Assignment of License of KHIZ(TV) from Sunbelt to Costa De Oro Television, Inc. (FCC File No. BALCT-20001002AHD)**

In a Petition to Deny and related documents, Ray Webb and Richard Sheldon alleged that the Applicants had failed to disclose facts, misrepresented facts and lacked candor regarding the assignment application. Costa De Oro Television, Inc. (“Costa”), the proposed assignee, denied these allegations in an Opposition. The application was subsequently dismissed at the request of Sunbelt as a result of a court decision in state court litigation.

**2. Application for Transfer of Control of Sunbelt as Licensee of KHIZ(TV) from Margaret Jackson (FCC File No. BTCCT-20011024AAU)**

Costa filed a Petition to Dismiss or Deny (which was treated as a Petition for Reconsideration) which alleged that Sunbelt had failed to disclose all necessary information. Sunbelt denied these allegations in an Opposition. The application was granted and the Petition of Costa was denied as was an Application for Review it subsequently filed.

**3. Application for Pro Forma Transfer of Control of Sunbelt as Licensee of KHIZ(TV) from Margaret Jackson to Mary Ellen Zenz (FCC File No. BTCCT-20010813AAT)**

Ray Webb filed an Informal Objection to the application stating that misleading information had been presented. Sunbelt filed an Opposition denying that any misleading

information had been presented. The application was subsequently dismissed at the request of the applicant.

**4. Application to Modify Station’s Licensed Facilities (FCC File No. BMPTTL-19960516LY; Application for Special Temporary Authority (FCC File No. BSTA-20011226ABA); Application for License to Cover (FCC File No. BLTTL-20020806AAB) – KSGA-LP**

Sunbelt filed various pleadings objecting to the permitting and licensing for low power television station KSGA-LP. KJLA, LLC (“KJLA”), the most recent licensee of KSGA-LP, alleged that certain interference claims submitted by Sunbelt constituted false and misleading representations. Sunbelt disputed the objections to its interference claims. Sunbelt filed a Motion to Dismiss Objections in these proceedings pursuant to a settlement agreement. That Motion was granted and Sunbelt’s pleadings have been dismissed.

**5. Sunbelt’s Application for Authority to Construct New Television Booster Station (FCC File No. BNPTTB-20030627AAB)**

KJLA filed a Petition to Deny Sunbelt’s booster application in which it questioned Sunbelt’s character qualifications and alleged that Sunbelt had pending character issues as a result of the allegations made against Sunbelt in the proceedings identified in Item 4 above. Sunbelt denied these allegations in an Opposition. Pursuant to the same settlement agreement referenced in Item 4 above, Sunbelt requested that its booster application be dismissed and the application was dismissed by the Commission.
