AGREEMENT

This Agreement ("Agreement") is entered into as of September 17th, 2010 by and between Cedar Rapids Television Company ("Cedar Rapids") and The Board of Trustees of the University of Illinois ("Illinois").

- 1. Cedar Rapids is the licensee of Station KCRG-TV, FCC Facility ID No. 9719. Cedar Rapids, Iowa, which is authorized by the Federal Communications Commission ("FCC" or "Commission") to operate on post-transition digital television ("DTV") channel 9.
- Illinois is the licensee of Station WILL-TV, FCC Facility ID No. 68939, Urbana, Illinois, which is authorized by the FCC to operate on post-transition DTV channel 9.
- 3. In an effort to restore over-the-air DTV service to certain of KCRG-TV's former analog viewers who presently are unable to receive its digital signal on channel 9, Cedar Rapids is seeking a construction permit from the FCC to increase KCRG-TV's power on channel 9 from 30.4 kW to as much as 49 kW with the following parameters (the "Proposed KCRG-TV Operations"):

Radiation Center Above Ground Level: 573 meters

HAAT: 607 meters

Antenna Height Above Mean Sea Level: 883 meters

Tower ASR: 1017602

- The Proposed KCRG-TV Operations will result in additional predicted interference to WILL-TV's authorized and proposed DTV facilities in excess of the Commission's interference limit of 0.5%.1
- Illinois hereby agrees to accept the predicted interference to WILL-TV caused by the Proposed KCRG-TV Operations.
- In consideration of Illinois' agreement in Paragraph 5, if, in the future, Illinois desires an increase in WILL-TV's power, Cedar Rapids hereby agrees that it will accept a similar proportion of predicted interference to KCRG-TV caused by WILL-TV.
- Except for the agreements set forth in Paragraphs 5 and 6 above, no consideration is being promised by either party in connection with this Agreement.
