PARTIES TO THE APPLICATION

As detailed in Exhibit 2, the instant application requests FCC consent to a series of transactions the ultimate result of which will be the *pro forma* assignment of the license of WCCU(TV), Urbana, Illinois from Urbana-Champaign Broadcasting Partners (“Assignor”) to Springfield Broadcasting Partners (“Assignee”). Pursuant to the proposed transactions, Assignor will cease to exist. Urbana-Champaign Television Inc., which is currently a 99% partner in Urbana-Champaign Broadcasting Partners, will merge into Springfield Independent Television Company, Inc. (“SITCI”). SITCI currently is, and will remain, a 99% partner in Assignee. Bahakel Broadcasting Company, which is currently a 1% partner in each of Assignee and Assignor, will remain a 1% partner in Assignee after the proposed *pro forma* assignment.
