There are five markets in which there is Grade B overlap between television stations ultimately owned and controlled by PCC and stations ultimately owned and controlled by Granite. The Paxson stations with Grade B contours that overlap Granite controlled stations are: Station WPXD(TV), Ann Arbor, Michigan; Station WPXJ(TV), Batavia, New York; Station WSPX-TV, Syracuse, New York; Station KPXF(TV), Porterville, California; and Station KKPX(TV), San Jose, California. The corresponding Granite stations are: Station WDWB-TV, Detroit, Michigan; Station WKBW-TV, Buffalo, New York; Station WTVH-TV, Syracuse, New York; Station KSEE(TV), Fresno, California; and Station KNTV(TV), San Jose, California. Mr. Greenwald has executed recusal statements with respect to each of the five Paxson controlled television stations in order to ensure compliance with the FCC's ownership rules. Both PCC and Granite have previously filed these recusal statements with the FCC.

Granite, its subsidiaries, and their officers, directors, and 5% or greater voting shareholders have no other broadcast ownership interests. Neither Granite nor any of its subsidiaries has any interests in any daily newspapers or cable television systems. None of the officers, directors, or 5% or greater voting shareholders of Granite have any interests in any daily newspapers or cable television systems.
