Dear Counsel:

This is in reference to the request filed February 8, 2011, on behalf of PJ Radio, LLC ("PJR"). PJR requests further extension of the special temporary authority ("STA") granted on June 26, 2008, to operate Station WTSX with emergency antenna facilities pursuant to Section 73.1680.¹ In support of the request, PJR states that the licensed tower was found by the owner to be structurally defective and was replaced by a new tower adjacent to the old tower. PJR states that it was not possible to move the licensed antenna to the new tower, but that a temporary antenna was installed on the new tower. PJR requests extension of STA pending implementation of Construction Permit BPH-20081104AFA (*See Note 1, below*).

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that the licensee has made progress toward restoring licensed operation but

¹ WTSX is licensed for operation on Channel 244A (96.7 MHz) with effective radiated power ("ERP") of 3 kW (H&V) and antenna height above average terrain ("HAAT") of 91 meters. Construction Permit BPH-20081104AFA authorizes a change in community of license to Lehman Township, Pennsylvania; relocation of the transmitter and operation with ERP of 5 kW (Max-DA, H&V) and HAAT of 70 meters.

that additional time is required for completion of the work. Thus, extension of STA is warranted.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station WTSX may continue to operate with the following facilities:

Effective radiated power:	2.8 kilowatts (H&V)
Antenna height:	
above ground:	50 meters
above mean sea level:	378 meters
Above average terrain:	93 meters

PJR must notify the Commission when licensed operation is restored. PJR must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. See 47 CFR § 1.1310.

This authority expires on **October 18, 2011**.
