ENGINEERING STATEMENT

## **PURPOSE AND SCOPE**

This Engineering Statement has been prepared on behalf of Vox Communications Group, LP (“Vox”), the proposed assignee of FM broadcast station WAVK(FM), Marathon, FL (Facility ID 23294). LSM Radio Partners, LLC, a company affiliated with Vox is the licensee of WWWW(FM), Marathon, FL (Facility ID 34355). This Statement addresses the overlap of the 70 dBu F(50,50) contours of WAVK(FM) and WWWW(FM) and other broadcast facilities in the WAVK(FM) / WWWW(FM) market.

## **WWWK(FM) - WAVK(FM) OVERLAP**

As shown in the attached Figure 1, the WAVK(FM) licensed 70 dBu F(50,50) contour overlaps almost entirely WWWW(FM) licensed 70 dBu F(50,50) contour. The market of interest is therefor defined by the overlap area of the licensed WAVK(FM) 70 dBu contour and licensed WWWW(FM) 70 dBu contour.

## **STATIONS IN MARKETS**

Also plotted in Figure 1 of this Statement are the antenna sites, and where applicable the 70 dBu F(50,50) contours, of some of the other FM stations in the vicinity of WAVK(FM) and WWWW(FM).

As shown in Figure 1, at least the following facilities have transmitter sites within the defined market or have 70 dBu contours that overlap, in part, the defined markets.

WAVK(FM)	288C2	Marathon Key, FL
WWWK(FM)	249C2	Marathon Key, FL
WMFM(FM)	300C1	Key West, FL
WGMX(FM)	232C2	Marathon, FL
WKYZ(FM)	267C2	Key Colony Beach, FL
WWUS(FM)	282C1	Big Pine Key, FL

The transmitter site of each radio station listed above is located within 92 km of the mutual overlap area of WAVK(FM) and WWWW(FM).

## CONCLUSIONS

The market defined by the WAVK(FM) and WWWK(FM) 70 dBu contours contains at a minimum, six FM facilities.


