

Lotus Communications Corp. & Affiliates**Los Angeles, California****I. Overview**

Lotus Communications Corp., a California corporation ("**Communications Corp.**"), is a holding and operating company, with headquarters at 3301 Barham Boulevard, Suite 200, Los Angeles, California 90068. Communications Corp. has seven corporate subsidiaries and two limited liability companies, aggregating nine affiliates, who are licensees of radio or low-power television stations, in addition to Lotus Los Angeles Corp., a newly-formed California corporation that does not yet hold any license, the assignee under this application (collectively, the "**Company**"). The Company's broadcast holdings, which are summarized on the attached organizational chart, break down to (i) 31 full-power radio stations and (ii) two low-power television stations (plus five FM translators). The radio stations are in Arizona, California and Nevada; the low-power television stations are in Arizona and Texas.

Communications Corp., the existing licensee, owns all issued and outstanding shares of Lotus Los Angeles Corp., the proposed assignee under this application. The outstanding equity of Communications Corp. is comprised of 1144 shares of issued and outstanding common stock, 500 shares of which (approximately 44%) are Class A, which is voting stock (the "**Voting Stock**"), owned equally by the Howard A. Kalmenson Trust (Howard A. Kalmenson, Trustee) and the Lilli Kalmenson Rosenbloom Trust (Lilli Kalmenson Rosenbloom, Trustee), and 644 shares of which (approximately 56%) are Class B, which is non-voting. Communications Corp. wholly controls its licensee affiliates, with Howard A. Kalmenson exercising Communications Corp.'s voting power in the affiliates, as well as voting all shares of the Voting Stock. Consequently, he alone controls Communications Corp. and each licensee-affiliate, including the proposed assignee. No other entity has any voting interest in the Company, including the proposed assignee.
