

MULTIPLE OWNERSHIP SHOWING

The applicant hereby demonstrates that grant of the application will be fully consistent with the Commission's local radio ownership rule. The Commission's local radio ownership rule provides that in markets with 45 or more full-power, commercial and noncommercial radio stations, one party may have a cognizable interest in licenses for up to eight commercial radio stations, no more than five of which are in the same service (AM or FM). 47 C.F.R.

§ 73.3555(a)(1)(i). The Commission defines the relevant market to be the "Arbitron Metro," in those markets so designated by Arbitron. *See 2002 Biennial Regulatory Review – Review of the Commission's Broadcast Ownership Rules and Other Rules Adopted Pursuant to Section 202 of the Telecommunications Act of 1996*, 18 FCC Rcd 13620, 13712-13 (2003).

For purposes of the local radio ownership rule, Radio Stations KUFO-FM, Portland, Oregon, KXJM(FM), Banks, Oregon, KUPL-FM, Portland, Oregon and KLTH(FM), Lake Oswego, Oregon are each deemed to be a part of the Portland, Oregon Arbitron Metro.

According to BIA Research, Inc.'s *Media Access Pro* database as of November 17, 2008, there are 55 full-power, commercial and noncommercial radio stations licensed to communities within the Portland Metro or which Arbitron designates as "home" to the Portland Metro.

Accordingly, the current local radio ownership rule permits the applicant to have a cognizable interest in eight commercial radio stations (with five in the same service) in the Portland market.

The applicant either directly or indirectly through affiliate companies has a cognizable interest in six radio stations in the Portland Arbitron Metro -- five in the FM service and one in

the AM service.¹ Accordingly, grant of this application is fully consistent with the local radio ownership rule.

¹ These stations are: KCMD(AM), Portland, OR (Facility ID #26926); KINK(FM), Portland, OR (Facility ID #53068); KLTH(FM), Lake Oswego, OR (Facility ID #4115); KUFO-FM, Portland, OR (Facility ID #26932); KUPL-FM, Portland, OR (Facility ID #4114); and KXJM(FM), Banks, OR (Facility ID #12551).
