Blanchard, Barbara Jensen, James Jensen, Kevin Jensen, Catherine Jensen, Nellow Westover, Iris Cartright, Scott Winter and Tim and Tammey Nesmith are currently principals of Southern Utah Broadcasting Company (“Southern Utah”), licensee of Stations KSUB(AM) and KCIN(FM), Cedar City, Utah (Facility Identification Numbers 61384 and 61386). Wallace C. Brazzeal, L. Brent and Debra L. Miner, BRC Limited Partnership, Thomas and Patti Goodman, Daryl Farnsworth, Jack Lancaster, Joshua Aikens, Sherry Bradbury, Daniel Hobson, John Cribbs, Rick and Christine Harris, and Bernard VanBenthem are principals of Media Broadcasting, Inc. (“MB Broadcasting”), licensee of low power television Stations KDLQ-LP, St. George, Utah, KDLU-LP, St. George, Utah, KVBT-LP, Santa Clara, Utah, K07PX, Rockville, Utah, K09KP, Toquerville, Utah, K11OP, Virgin, Utah, K32DJ, Enterprise, Utah (Facility Identification Numbers 39490, 56094, 70969, 70953, 70968, 70952 and 40802).

Southern Utah and MB Broadcasting are consolidating through the merger of both companies with and into MB Media, with MB Media as the surviving corporation. Consequently, simultaneously herewith, respective applications (FCC Forms 314 and 345) are being filed for consent to the assignment of licenses for Southern Utah’s Stations KSUB(AM) and KCIN(FM) from Southern Utah to MB Media (the “Southern Utah Application”) and for MB Broadcasting’s Stations KDLQ-LP, KDLU-LP, KVBT-LP, K07PX, K09KP, K11OP and K32DJ from MB Broadcasting to MB Media (the “MB Broadcasting Application”). In addition, another application on FCC Form 314 for the assignment of licenses for Stations KBRE(AM) and KBRE-FM, Cedar City, Utah (Facility Identification Numbers 35391 and 35392) from Kolob Broadcast Radio Enterprises, Inc. (“Kolob”) to MB Media (the “Kolob Application”) is being filed with the FCC simultaneously herewith. It is hereby requested that the Commission process the instant application for the assignment of Station KCCA from Uzona Broadcasting Company (Uzona Broadcasting”) to MB Media with the Southern Utah, MB Broadcasting and Kolob Applications so that the assignment of the Southern Utah, MB Broadcasting, Kolob and Uzona Broadcasting stations can be consummated at the same time.
