#### **Other Media Interests**

Media General, Inc., through subsidiaries, publishes daily, weekly, and/or Sunday newspapers in the following communities: Tampa, Florida; Marianna, Florida; Brandon, Florida; New Port Richey, Florida; Concord/Kannapolis, North Carolina; Eden, North Carolina; Marion, North Carolina; Morganton, North Carolina; Statesville, North Carolina; Reidsville, North Carolina; Winston-Salem, North Carolina; Hickory, North Carolina; Mooresville, North Carolina; Madison, North Carolina; Richmond, Virginia; Culpeper, Virginia; Brooksville, Florida; Sebring, Florida; Manassas, Virginia; Woodbridge, Virginia; Waynesboro, Virginia; Charlottesville, Virginia; Lynchburg, Virginia; Danville, Virginia; Orange, Virginia; Richlands, Virginia; Bristol, Virginia; Abingdon, Virginia; Wytheville, Virginia; Amherst, Virginia; Florence, South Carolina; Dothan, Alabama; Enterprise, Alabama; Opelika-Auburn, Alabama; Stafford, Virginia; and Mechanicsville, Virginia.

Media General, Inc. is controlled by a single majority shareholder pursuant to the various voting rights and restrictions set forth in the company's Articles of Incorporation (the "Articles"). The voting rights of the holders of Class A voting stock (the "Class A Stockholders") are limited. The Class A Stockholders voting separately and as a class are entitled to elect thirty percent of the Board of Directors; the Articles provide for the holders of Class B voting stock (the "Class B Stockholders") to elect the balance of the Board (Articles at II.B.(2)(a)). Thus, of the company's nine current directors, three are "Class A Directors" elected by the Class A Stockholders and six are "Class B Directors" elected by the Class B Stockholders. (The Articles provide for a minimum of eight and a maximum of twelve directors.) Otherwise, the Class A Stockholders vote only on corporate events that would dilute their ownership in the company or that involve related-party transactions. They are entitled to vote on: (i) reservation of shares of the company's stock for the granting of stock options to officers, directors and employees; and (ii) acquisition by the company of the stock or assets of another entity under certain circumstances, including specifically (x) where any officer, director, or greater-than-10% Media General, Inc. shareholder has an interest in the entity or assets to be acquired or in the consideration being paid, (y) where the transaction involves the issuance of new Media General, Inc. securities whose aggregate number (taking into account the conversion of any convertible securities so issued) would constitute 20% of the aggregate number of Class A and B shares already outstanding, or (z) where the transaction involves the issuance of new Media General, Inc. securities or other consideration and the value of such would constitute 20% or more of the aggregate value of Class A and B shares already outstanding (Articles at II.B.(3)(a)). Beyond these minority shareholder protection rights, the Class A Stockholders are not entitled to vote on any other matter.

Consequently, control over the day-to-day business operations of Media General, Inc., including control over day-to-day broadcast station operations, rests with the Class B Stockholders. The D. Tennant Bryan Media Trust (the "Media Trust"), whose sole trustee is J. Stewart Bryan III, holds approximately 67% of the Class B voting stock of Media General, Inc. Through the Media Trust and Class B shares held directly by Mr. Bryan, Mr. Bryan has voting control of 84% of the Class B shares. He thus controls the Board and the company in light of the above-described Class A voting restrictions and is the single majority shareholder of Media General, Inc. within the meaning of Section 73.3555 of the Commission's rules. Accordingly, Media General, Inc.'s minority

shareholders are non-attributable. *See Review of the Commission's Regulations Governing Attribution of Broadcast and Cable/MDS Interests*, 16 FCC Rcd 22310 (2001).

Media General, Inc. owns all of the outstanding voting stock of Media General Communications, Inc. Media General Communications, Inc. owns all of the outstanding voting stock of Media General Operations, Inc., which, in turn, owns all of the outstanding voting stock of Media General Broadcasting of South Carolina Holdings, Inc.
