subsequent acts and treaties, and all regulations heretofore or hereafter
made by this Commission, and further subject to the conditions set forth
in this permit, the permittee is hereby authorized to construct the radio
transmitting apparatus herein described. Installation and adjustment of
equipment not specifically set forth herein shall be in accordance with
representations contained in the permittee's application for construction
permit except for such modifications as are presently permitted, without
application, by the Commission's Rules.

- 270 degrees True: 0.53 kilowatts
- 330-340 degrees True: 0.70 kilowatts

Special operating conditions or restrictions:

- 2 The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.

- 3 Georgia Public Telecommunications Commission requests waiver of 47. C.F.R. Section 73.1125 to operate the proposed facility at Georgia Public Telecommunications Commission's headquarters located at 260 14th Street, N.W., Atlanta, Georgia. Based upon the specific representations contained therein, the waiver request IS GRANTED. Applicant shall abide by each representation proffered in the waiver request.
