

PARTIAL ASSIGNMENT OF ASSET PURCHASE AGREEMENT

THIS PARTIAL ASSIGNMENT OF ASSET PURCHASE AGREEMENT (this “Partial Assignment”), is made as of October 11, 2011, by and between Chena Broadcasting, LLC, an Alaska limited liability company (“Assignor”), and Tanana Valley Television Company, an Alaska corporation (“Assignee”).

WHEREAS, Assignor is a party to that certain Asset Purchase Agreement, dated October 11, 2011 (the “Purchase Agreement”), between Assignor (as Buyer thereunder) and Newport Television License LLC (as Seller thereunder), with respect to television broadcast station KTVF(TV), Fairbanks, Alaska (the “Station”); and

WHEREAS, Assignor desires to assign certain of its rights and obligations under the Purchase Agreement to Assignee, and Assignee desires to accept such rights and assume such obligations from Assignor; and

WHEREAS, capitalized terms used herein and not defined shall have the respective meanings set forth in the Purchase Agreement; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. Assignor does hereby assign to Assignee the right of Assignor to receive an assignment from Seller of certain of the Station Assets, including the Tangible Personal Property listed on Schedule 1.1(b) hereto; the Owned Real Property listed on Schedule 1.1(c) hereto; the Station Contracts listed on Schedule 1.1(d) hereto; the Intangible Property listed on Schedule 1.1(e) hereto; and all files, documents, and records related to the Station Assets listed on Schedules 1.1(b), (c), (d), and (e) hereto (collectively, the “Assigned Assets”).

2. Assignee does hereby accept from Assignor the right of Assignor to receive an assignment of the Assigned Assets identified above, and agrees to assume all obligations related to such Assigned Assets.

3. Upon execution of this Agreement, Assignee shall pay Assignor the sum of \$100,000 for the right to receive the assignment of the Station Assets set forth in Section 1 herein. Upon the consummation of the Purchase Agreement by Assignor, Assignee shall pay Assignor the sum of \$1,000,000.00, subject to further adjustment by mutual agreement, to complete the assignment as contemplated in this Agreement.

3. Except as otherwise assigned hereby, Assignor retains all of its other rights and all of its obligations under the Purchase Agreement, including, but not limited to, all of its rights and obligations regarding the FCC Licenses.
