

DESCRIPTION OF TRANSACTION

This is one of five simultaneously filed applications pertaining to the proposed acquisition by subsidiaries of Townsquare Media, LLC (“Townsquare”) of certain stations currently licensed to Revitalization Partners, LLC, General Receiver (“the Receiver”), which previously were licensed to New Northwest Broadcasters, LLC (“New Northwest”). The overall transaction also contemplates the assignment of certain stations licensed to the Receiver or subsidiaries of Townsquare to a divestiture trust, as set forth below.

The Receiver assumed control of the former New Northwest radio station properties as a result of insolvency proceedings in the Superior Court for the State of Washington for King County (the “Court”), pursuant to the order of that Court and the approval of the Commission. (*See* BAL-20100517ADY) The Receiver is administering the property of the debtor New Northwest subject to the general provisions of the Washington statute applicable to general receiverships and the court rules applicable to them. (*See* WASH. REV. CODE § RCW Ch.7.60). As part of a Court-supervised process for resolving the estate of the debtor New Northwest, the Receiver is seeking expeditiously to assign all of the former New Northwest radio stations to new owners for the benefit of New Northwest’s creditors. The transaction with Townsquare described below is part of that ongoing process.

The Receiver, in connection with its duties to New Northwest’s creditors and for the benefit of those creditors, now seeks Commission consent to assign certain of the former New Northwest stations to two subsidiaries of Townsquare: Townsquare Media Tri-Cities License, LLC and Townsquare Media Yakima License, LLC (collectively, the “Townsquare Subsidiaries”).

Townsquare Media Tri-Cities License, LLC currently is the licensee of the following stations in the Tri-Cities, Washington Arbitron Metro:

The Commission’s multiple ownership rules limit the number of stations that Townsquare may hold in each market. Therefore, as set forth on the below chart, Townsquare and the Receiver propose to assign certain of the former New Northwest stations to the Tri-Cities/Yakima Divestiture Trust (the

“Trust”). In addition, Townsquare proposes to assign to the Trust certain other stations presently licensed to its subsidiaries. The five applications being filed in connection with this transaction are:

As set forth in Exhibit 16 to each application, the overall transaction complies with Section 73.3555 of the Commission's rules. Because each application demonstrates compliance with the Commission's multiple ownership rules, no waiver of the rules is being sought and the Commission may grant each application on its face. The use of an independent divestiture trust previously has been approved in similar circumstances to accommodate transactions involving court-approved assignments for the benefit of creditors. (E.g., Application for Transfer of Control Nassau Broadcasting II, L.L.C., 25 FCC Rcd 1851 (Audio Div., Feb. 25, 2010) and Applications of Regent Trust to The Fort Collins/Lafayette Divestiture Trust, FCC File No. BALH-20100323AIF, *et seq.* (granted June 30, 2010)).

Grant of the present applications is in the public interest because it will allow the Receiver to fulfill its duties with respect to New Northwest's creditors in an expedient manner and also ensure that listeners of the subject New Northwest stations will not suffer any disruptions of service.
