## **1Miami, Inc.**

1Miami, Inc. is a Florida non-profit organization incorporated on April 14, 2011 that is dedicated to educating the public and promoting policies that enhance the wellbeing of workers and their families. 1Miami's coalition of community groups, neighbor associations, faith organizations, and workers has been building a movement around access to good jobs, an excellent education, and affordable health care for all Miami residents. 1Miami also educates the public on the importance of good jobs, education, and access to health care.

1Miami has moved locations since it originally incorporated in 2011, but has been located within 10 miles of the proposed site and has been working in the same low-income communities in Miami since its inception. The address on the original articles of incorporation filed with the State of Florida was 333 W. 41<sup>st</sup> Street, Miami Beach, FL 33140. 1Miami's current address is 14 NE 1st Ave, #905, Miami, FL 33132.

The proposed low power FM station would advance the educational mission of 1Miami around these important local issues affecting the city's many communities by providing a platform for a more diverse set of voices. The radio station would broadcast a mix of news, music, and other entertainment reflective of local Miami culture.

Proposed programming includes:

- Late Morning/Lunch (9am-12pm)
  - o Morning news updates
  - o Syndicated content such as Democracy Now!
  - o Genre-based music programming (jazz, classical, folk, hip-hop, electronic, etc.)
  
- Afternoon (1-4pm)
  - o Genre-based music programming rotating daily
  - o Kids show
  
- Late Afternoon (4-7pm)
  - o Local, state, and regional news
  - o Call-in talk shows
  - o The LAB report – news and updates from the LAB Miami
  
- Evening (7-9pm)
  - o Talk shows featuring local radio personalities, such as the Let's Talk About It! Radio show, discussing local, regional, national, and international news.
  - o Entertainment-oriented show, such as music and film news presented by Sweat Records and O Cinema
  - o The Bike Mic: news from the Miami Bike Scene
  
- Late Evening (9-12am)
  - o Live local DJ programming: showcasing a Miami DJ each night of the week
