

Description of Licensee

Non-commercial educational FM Station WJPZ-FM is licensed to WJPZ Radio, Inc. (“WJPZ”), a non-stock, not-for-profit corporation. In addition to service to the community and listening area, WJPZ was organized to provide a professional educational medium in radio for Syracuse University students. WJPZ’s studios are located at Syracuse University, and its Board of Directors (the “Board”) is comprised of individuals who are either students, faculty, or otherwise connected with or interested in Syracuse University. WJPZ is governed by its Board, which is self-perpetuating.¹ Each Board member has one vote and serves for terms of either one or two years, depending on the seat held.

Purpose of Application and Use of Form 316

The purpose of this application is to establish control for the Board listed on Page 3 of this exhibit. No written agreements exist documenting the changes herein listed, as they occurred through the ordinary processes of attrition and appointment of new Board members.

As is typical of non-profit, non-commercial educational licensees, the composition of the Board has gradually changed. Accordingly, use of Form 316 is appropriate for this application. The attached table identifies those individuals who have served as directors between 2011, the year that WJPZ-FM’s most recent 316 was approved, and the present. Whenever a Board member’s term of office was in effect the individual is included in the attached chart for that year.
