***NOTE: The ownership details described in this attachment have been previously approved by the Commission and are unchanged by the instant application. (The only changes requiring commission approval involve the transfer of a 50 % ownership interest in Barba Television, Co. from Carlos to Teresa Barba, as requested in the application form itself.)***

The licensee, **S&E Network, Inc.**, is wholly owned by CaribeVision Station Group, LLC, a Delaware LLC, which controls 100% of the equity and votes. Carlos Barba is CEO of S&E Network, Inc.

**CaribeVision Station Group, LLC** is wholly owned by CaribeVision Holdings Corp., a Delaware corporation, which is also the LLC's manager.

**CaribeVision Holdings, Inc.** is owned 80.73 % by Barba TV Group, LLC, which is organized in Florida, and 19.27 % by Pegaso Television Corp., a Delaware corporation. (The interest holders in Pegaso Television Corp. are listed on page 3 of this exhibit.)

The officers and directors of CaribeVision Holdings, Inc. are: Carlos Barba, President CEO and Director (U.S. Citizen).

*The chairman exercises no super-voting or similar rights.*

In addition, Enrique De La Campa, c/o Suite 500, 1401 Brickell Avenue, Miami, FL 33131 (Mexican Citizen), is Vice President, Secretary and Treasurer, but is not a board member.

***Therefore, as previously passed on by the Commission, three of this entity's four controlling board members are U.S. citizens.***
