Dear Mr. Friemel:

This letter is in reference to the above captioned minor change application filed by Raftt to modify the KYRO(AM) licensed facility by changing the city of license from Potosi, Missouri, to Troy, Missouri.

A preliminary review reveals that:

1. The KDKD(AM) measurements on 26°, 45°, 65°, and 85° radials are not acceptable because they do not contain at least seven close-in points within 3 km, as required by Section 73.186 of the Commission's rules. Without use of these measurements, the KDKD(AM) and proposed 0.5 mV/m and 0.025 mV/m contours will overlap, in violation of Section 73.37(a) of the Commission's rules.
2. Raftt proposes to duplex and utilize only part of the existing 118.9 meter tower of the KDKD(AM) antenna, therefore an explanation must be submitted to explain how can Raftt use the lower 58.5 meter part of the tower as a folded unipole antenna.
3. The environmental statement given in Exhibit 19 is unacceptable because it does not meet the requirements set forth in the environmental checklist given on web page http://wireless.fcc.gov/siting/EA_checklist.pdf. If the site has been found acceptable for use from an environmental viewpoint, Raftt should amend to certify "YES" on question #11 (Environmental Protection Act) and remove all additional text qualifications given in Exhibit 19. Otherwise an amendment showing compliance with the checklist must be submitted.

Further action on the subject application will be withheld for thirty (30) days from the date of this letter to allow Raftt time to amend. Failure to amend or respond within this time period will result in the dismissal of the application pursuant to Section 73.3568 of the Commission's rules.
