## COMPREHENSIVE TECHNICAL EXHIBIT

**Application for New digital LPTV facility  
NEW, Kalispell, MT  
EICB-TV East, LLC**

**Application for New Facility.** The within filing seeks a new facility in response to FCC Public Notice DA 09-1487, *Rural First Come, First Served* Filing Opportunity. The within filing is located at Kalispell, MT and is in excess of 121 km (75 miles) from any top 100 market city listed within the announcement.

**Interference Analysis.** An OET 69 Longley-Rice study exhibit for the above-captioned application was performed employing the Techware, Inc. FCC interference analysis program on a Sun Blade computer. The study demonstrates that the within proposal is in compliance with all applicable portions of §74.793 with the exception of KSKC-CA. In regard to that, a letter of acceptance of predicted interference to that facility from the within application is attached to this exhibit and, by reference, made a part hereof.

**Canadian Border Area application.** This application is filed at a site within the Canadian border area. It has been designed to not permit the application's F,50,10 signal in excess of 19.5 dBu to cross the border and therefore should not be subject to submission to Canadian authorities for frequency coordination.

**Use of Unregistered Tower.** The within application specifies a tower located among a group of communication towers in common use on Blacktail Mountain, MT. The use of the FCC TOWAIR program yields the information that the 15 meter tall tower is in excess of 8 km from any airport; thus, it needs no registration.
