

**OWNERSHIP STRUCTURE AND BROADCAST INTERESTS**

Overview

Univision Communications Inc. (“UCI”) through three principal subsidiaries, Univision Television Group, Inc. (“UTGI”), Telefutura Television Group, Inc. (“TTGI”), and Univision Puerto Rico Station Acquisition Company, is the parent of the licensees of television broadcast stations. Through a fourth principal subsidiary, Univision Radio, Inc. (“Univision Radio”), UCI is the parent of the licensees of radio broadcast stations. The Commission has also held that UCI has an attributable interest in certain television stations licensed to Entravision Communications Corporation (“Entravision”). UCI is 100 percent owned by Broadcast Media Partners Holdings, Inc. (“BMPHI”). 100 percent of the voting interests and 80 percent of the equity interests of BMPHI are held by Broadcasting Media Partners Inc. (“BMPI”). The remaining 20 percent of the equity interests of BMPHI are held directly by the shareholders of BMPI. BMPI and BMPHI do not have other attributable media interests. However, certain of the shareholders in BMPI and BMPHI hold other broadcast interests. The attributable shareholders of BMPI and BMPHI are certain commonly controlled affiliates of Madison Dearborn Partners, LLC; Providence Equity Partners Inc.; Saban Capital Group; and Texas Pacific Group.

UCI’s interests held through UTGI are described in Section I below. UCI’s interests held through TTGI are described in Section II below. UCI’s interests held through Univision Puerto Rico Station Acquisition Company are described in Section III below. UCI’s ownership interests held through Univision Radio are described in Section IV below. UCI’s attributable interests in certain Entravision television stations are described in Section V below. The other broadcast interests of the shareholders of BMPI and BMPHI are described in Section VI below.

I. Univision Television Group, Inc.

UTGI is wholly owned by PTI Holdings, Inc. (“PTI”), which, in turn, is wholly owned by UCI. UTGI is the sole owner and licensee of WSTE(TV), Ponce, Puerto Rico (FIN: 60341), WSTE1, San Juan, Puerto Rico (FIN: 91770), WSTE2, Mayaguez, Puerto Rico (FIN: 91773), and WSTE3, Arecibo, Puerto Rico (FIN: 91771).
