Purpose of Application And Information Concerning Composition of Board of Directors

Noncommercial educational FM Station KABF(FM) is licensed to Arkansas Broadcasting Foundation (“ABF”), a not-for-profit corporation. ABF is governed by a Board of Directors which is self-perpetuating, that is, when vacancies occur, new directors are elected to the Board by a majority of the existing Directors. Each Board member has one vote, and each serves for a three-year term.

The purpose of the instant application is to obtain Commission consent to the current membership of ABF’s Board.

Station KABF has been licensed to operate for more than 20 years. While ABF is uncertain as to the precise membership of the ABF Board specified in its original construction permit application – and, therefore, the identities of individuals who became “approved parties” with the grant of that application – the Commission’s files indicate that ABF routinely filed Ownership Reports (FCC Form 323-E) in 1981, 1985, 1989, 1995, 1996, 1998 and 2003.¹ ABF also routinely filed renewal applications (FCC Form 303-S) in 1989, 2006 and 2004, all of which were granted.

Review of ABF’s Ownership Reports, and comparison with the current membership of the ABF Board, indicates that the composition of the Board has gradually changed over the course of the 24-year period from 1981-2005, as reflected in the following table. That table identifies the individuals who have served as directors and were identified in reports (*i.e.*,

That search disclosed ownership reports – or, in some instances, materials identifiable as portions of ownership reports – filed which had been filed with the Commission.
