In previous Ownership Reports, Diocese of St. Petersburg has reported that there is a Board of Directors and that certain individuals serve thereon, as set forth in the chart above. At the time the license was granted in 1999, licensee reported that five individuals served on a Board of Directors, and these individuals were approved by the Commission at that time. Of those original five, The Most Reverend Robert N. Lynch and Mrs. Elizabeth Deptula remain on the Board. Mr. Urbanski left in 2001 and was replaced by Rev. Msgr. Frank Mouch for one term, leaving four of the original board members. Reverend Weber replaced Rev. Msgr. Much for one term in 2003. That position was filed in 2005 by Mr. Murphy who remains on the board. At the time the 2007 Biennial Ownership Report was filed with the Commission, fewer than 50% of the approved Board Members remained on the Board.

Although the Board Members have been disclosed to the Commission, the nature of the licensee, The Bishop of The Diocese of St. Petersburg as a corporation sole and the members of the Board is to serve an advisory board to the Bishop of the Diocese. The Bishop is not bound by the recommendations of the Board. Ultimate control of the Diocese, and therefore the station, remains with the Diocese and the Bishop as a corporation sole. Thus, any change in the Board Membership is pro forma but does not change who actually controls and makes decisions for and on behalf of the Diocese. Nonetheless, in order to remain consistent with its prior filings, licensee submits this Amendment to its Transfer of Control Application.
