

MULTIPLE OWNERSHIP SHOWING

Attached is a copy of the BIA FCC Geographic Market Definition Report for the Columbus, Georgia radio market. The report demonstrates that there are 21 full-power commercial and noncommercial stations in the Columbus, Georgia radio market. Section 73.3555(a)(i) of the FCC's rules provides that in a radio market with 15 to 29 full-power, commercial and noncommercial radio stations, a single entity may not have a cognizable interest in more than 6 commercial radio stations in total and not more than 4 commercial stations in the same service (AM or FM).

In the Columbus, Georgia radio market, Davis Broadcasting, Inc. of Columbus ("Davis") is the licensee for WFXE(FM), WEAM(AM), and WOKS(AM), Columbus, Georgia; WIOL(FM), Greenville, Georgia; WKZJ(FM), Eufaula, Alabama; and WEAM-FM, Buena Vista, Georgia. Thus, Davis has a cognizable interest in a total of 2 AM and 4 FM commercial radio stations in the Columbus, Georgia radio market. Grant of the minor change request for the licensed facility for WFXE(FM) will result in no change to Davis' cognizable interests in the Columbus, Georgia radio market. Accordingly, the minor modification of radio station WFXE(FM), Columbus, Georgia would fully comply with the FCC's local radio ownership rule (47 C.F.R. Section 73.3555(a)).
