Notification of Increased Digital Power

Dear Sir or Madame:

On behalf of Entercom Wilkes-Barre Scranton, LLC ("**Licensee**"), licensee of WDMT(FM) ("**Station**"), (Facility ID No. 22925), the Commission is hereby notified of the increase in the digital effective radiated power of Station effective October 15, 2010.

Licensee hereby certifies that except for the power increase, its facilities conform to the iBiquity specifications. In the event of interference, questions should be directed to Licensee's local technical representative, Mr. Jay Waggoner at (570) 883-9850.

Station is operating with the following transmitter output power:

- Analog transmitter power: 6.0kW
- Digital transmitter output power: 0.85kW
- Combined Analog & Digital (Post Combiner) power: 5.49kW

Licensee hereby certifies that the WDMT(FM) maximum analog effective radiated power of 5.8kW has remained unchanged since commencement of digital operations. The digital effective radiated power is now 0.099kW (99 watts).

Licensee hereby certifies that the notified operation will not cause human exposure to levels of radio frequency radiation in excess of Section 1.1310 of the Commissions' rules and is therefore categorically excluded from environmental processing pursuant to Section 1.1306(b).

The undersigned counsel is authorized to represent that neither the licensee nor any party holding an attributable interest in the licensee is subject to a denial of federal benefits pursuant to Section 5301 of the Anti-Drug Abuse Act of 1988, 21 USC Section 862.
