Pursuant to C.F.R. 47 §73.1670 Auxiliary transmitters.- (c)(3), Calvary Chapel of Twin Falls, Inc. ("CCTF") respectfully notifies the Commission that KAWS Marsing, Idaho, Facility ID 8417, is operating under its Auxiliary Antenna and Transmitter system as of February 14, 2008, License File No: BXLED-20080214AHE, KAWS Murphy, Idaho, Facility ID # 8417.

On February 7, 2008 CCTF notified the Commission, via a letter (attached), that it was operating at a reduced power on its main transmitter. Since that time a CCTF crew visited the transmitter site and found that massive ice damage had rendered the antenna system of KAWS, Marsing unusable and the transmitter was shut off. An application for an auxiliary operation was applied for and granted under BXPED-20080211AEJ and is now on air under License File No: BXLED-20080214AHE. CCTF intends to operate the auxiliary antenna and transmitter until such a time that a new main antenna system can be received and installed. This process will take longer than the 10 days specified in C.F.R. 47 §73.1670. Once KAWS Marsing is back at full operational power under its specified license BLED-20070924AAP, CCTF will notify the FCC that normal operations have resumed.


Dear Staff,

Pursuant to C.F.R. 47 §73.1560 (d), Calvary Chapel of Twin Falls, Inc. ("CCTF") respectfully notifies the Commission that KAWS Marsing, Facility ID 8417, as of January 30, 2008, is operating its transmitter at reduced power on License File No: BLED-20070924AAP, KAWS Marsing. High SWR, due to possible ice damage to the 4-bay antenna system, has caused the transmitter power to be reduced. Adverse weather conditions have prevented site accessibility, but a CCTF crew is scheduled to visit the site on February 8, 2008.

Should the reduced power continue beyond 30 days, CCTF will request an STA to continue to operate under these present conditions, until such a time that the damage can be repaired.
