The proposed acquisition by the assignee herein, Barrington Michigan Corporation, of the outstanding construction permit for a new primary analog UHF commercial television broadcasting station that will operate on NTSC Channel 46 in Bay City, Michigan (Facility I.D. No. 82627), is consistent with Section 73.3555(b)(2) of the Commission's Rules as in effect on the date hereof.

As indicated in Exhibit 13 to this application, a commonly-owned affiliate of Barrington Michigan Corporation (Barrington Broadcasting Flint Corporation) holds the license from the Commission to operate primary analog UHF commercial television broadcasting station WEYI-TV on NTSC Channel 25 in Saginaw, Michigan (Facility I.D. No. 72052). As demonstrated in the attached map (the "Markley Map") prepared by Barrington Michigan Corporation's broadcast engineering consultants at D. L. Markley & Associates, Inc., dated May, 2004, the predicted Grade B field-intensity signal contour of the new station to be constructed in Bay City (identified on the map as "960710KZ at 1.6 MW") overlaps the equivalent signal contour of WEYI-TV.

Because the new station to be constructed in Bay City is not yet on the air, it obviously does not rank among the top four stations in its Designated Market Area ("DMA") at this time. (The relevant DMA here is the Flint-Saginaw-Bay City, Michigan DMA, ranked as the 64th largest DMA in the country. See *Broadcasting and Cable Yearbook*, 2003-04 (Reed Business Information), at Page B-162.)

Moreover, following the acquisition of the permit for the new station to be constructed in Bay City by Barrington Michigan Corporation, there will be at least eight independently-owned and operating full-power commercial and noncommercial television stations in that DMA, and the predicted Grade B field-intensity signal contours of each of those eight stations overlaps either or both of the equivalent signal contours of Station WEYI-TV or the new station to be constructed in Bay City, as shown in the Markley Map, as follows:
