

ASSET PURCHASE AGREEMENT

THIS ASSET PURCHASE AGREEMENT (the "Agreement") is made and entered into this 29th Day of August, 2013 by and between Canyon TV ("Assignor") and MMM License, LLC together with Max Media of Montana, LLC ("Assignee").

RECITALS

WHEREAS, Assignor is the licensee of and holds the FCC Authorizations used and useful in the operation of television translator station K07IT ("the Station") serving West Glacier and surrounding areas (Facility ID # 16756) and,

WHEREAS, subject to all necessary Consents of the FCC, Assignor desires to assign to Assignee the license and FCC Authorization ("FCC Authorization") of K07KT and Assignee desires to acquire both the FCC License and also the other current assets ("Other Assets") from Assignor that are used in the operation of the Station. The Other Assets are sold as is and in the current condition as of the execution of this Agreement and include a Larcan 8VSB Transcoder and a Larcan MX10D-V Power Amplifier and a one-third interest in the transmitter combiner, transmission line, and transmitting antenna array.

NOW, THEREFORE, in consideration of the purchase price of One Dollar (\$1.00) this transaction shall close on the fifth (5th) Business Day after the FCC shall have given written consent to the proposed assignment of FCC License. Within three (3) Business Days of the execution of this Agreement, the Assignee will prepare the FCC Form 345 application for FCC Consent to the assignment of the FCC Authorization listed above. Application and filing fees will be paid by the Assignee.
