TECHNICAL STATEMENT

This Technical Statement was prepared on behalf of Radio License Holding CBC, LLC (“Radio License Holding”), licensee of radio station WXKC, Channel 260B, Erie, Pennsylvania. Radio License Holding hold a construction permit (BXPB-20160322ADI) to construct an auxiliary facility for WKXC and is filing this application for station license to cover the outstanding construction permit. The detailed calculation of the transmitter power output for WXKC is attached as Exhibit A.

The outstanding construction permit has three special operating conditions or restrictions.

Condition #1 states:

“Auxiliary facilities for Stations WXKC (FAC. ID #32984 and WXTA (FAC. ID# 728962 are sharing an antenna. Only one Station will use this facility at a time.”

Radio License Holding is aware of this condition and pledges compliance.

Condition #2 states:

“This construction permit authorizes the mounting of an antenna on a directional tower of the AM station identified below. Prior to installation of the antenna, the permittee shall notify the AM station licensee so that, if necessary, the AM station may determine operating power by the indirect method (see Section 73.51 of the Commission’s Rules) and request a Special Temporary Authorization pursuant to Section 73.1635 of the Commission’s Rules to operate with parameters at variance. The permittee must conduct a partial proof of performance as defined in Section 73.154 of the Commission’s Rules both before and after construction to show that the AM station has not been adversely affected. If the operating parameters of the AM station differ from licensed values following the antenna installation, the results of the partial proof of performance shall be filed with the Commission by the AM station licensee using form FCC 302-AM. (See Section 1.30003 of the Commission’s Rules.) The permittee must submit confirmation of completion of the requirements of this condition in the application for license to cover this construction permit.

Station WRIE (AM), Erie, PA, Fac ID No. 32982”

Radio License Holding, the licensee of WRIE (AM), verifies that no actual construction to implement the auxiliary antenna was required. There has been an emergency antenna on this tower for some time. Further, WRIE (AM) is operating pursuant to BESTA-20160126AAS pending the repair and tuning of the directional array due to other factors. Thus it is not possible to comply with the before and after partial proof of the AM directional array. Radio License Holding respectfully requests a waiver of this condition.

Condition #3 states:

“The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.”

Radio License Holding is aware of its responsibility in this matter.

Based on the foregoing, it is believed that Radio License Holding CBC, LLC is in compliance with the Commission’s rules and requests to operate the WXKC auxiliary at 10.0 kilowatts.
