RESPONSE TO REQUEST FOR INFORMATION

Hall Communications, Inc. ("Hall"), licensee of WPCV(FM), Winter Haven, Florida, by its attorneys, hereby respectfully submits its Response to the two letters which it received from the Senior Deputy Chief, Audio Division, Media Bureau, one of which was dated August 27, 2019, Reference 1800B3-KV, and the other of which was dated September 9, 2019, Reference 1800B3-LHA, and both of which request further information in connection with interference complaints and informal objections filed by Hall with regard to the above-captioned applications. With respect thereto, the following is submitted:

This proceeding began with an Interference Complaint filed by Hall on September 29, 2017, with regard to the then-operation of W248CA, and has continued through various filings by NIA Broadcasting, Inc., the licensee of W248CA, and by Hall, which has been seeking to obtain a remediation of interference issues created by W248CA. As previously reported, those operations have varied over time, as have the proposals for future operation, but all of them relate to FM translator W248CA and either actual or potential interference with the reception of Hall's station WPCV.

When Hall first filed its Interference Complaint, W248CA was operating with the facilities authorized by license File No. BLFT-20170815AAH, the application for which had been filed to cover the station's construction permit, File No. BPFT-20160120AAH. That permit specified operation with a directional composite antenna, a radiation center above ground level height of 166 meters, and Effective Radiated Power ("ERP") of 0.25 kW. As demonstrated by Hall's Interference Complaint, that operation created significant interference to the reception of Hall's station, WPCV, and it provided listener declarations and technical showings to support its Interference Complaint.

Subsequently, in response to the Interference Complaint, as of November 6, 2017, NIA reduced the power level at which W248CA was operating and sought Special Temporary Authority for such reduced power operation. *See*, BSTA-20171107AAE. Subsequently, NIA filed an application for modified facilities, File No. BPFT-20180117ACJ, which proposed a directional composite antenna with a center of radiation at 110 meters above ground level and an ERP of 0.13 kW. At that time, it was hoped that the lower height, lower power, and an orientation more away from WPCV would alleviate the interference issues, and it is these facilities which are currently authorized by W248CA's license, File No. BLFT-20180328AAW.

As the record of this proceeding reflects, during the time period immediately before and following the filing of the W248CA modification application, Hall and NIA were attempting to work together, and had reached an agreement in principle with regard to many of the issues at hand. *See, e.g., "Update to Interference Complaint and Request for Immediate Suspension of Authority to Broadcast,"* filed by Hall on March 27, 2018, and the parties attempted to agree upon testing dates and procedures, but were unable to do so. *See, Hall's Informal Objection,* filed June 4, 2018. While these efforts did not result in a resolution of the issues between the

parties, they do demonstrate that the parties were communicating with each other, that NIA was aware of the issues, and that there were attempts to address the matter.

This history also makes it clear that the currently authorized facilities for W248CA are not the same as those which were operating at the time that Hall filed its initial Interference Complaint. While the Commission's initial letter has requested further information to substantiate that complaint, since the W248CA facilities ceased to operate in that manner nearly two years ago, it is impossible for Hall to locate further complainants or provide additional, current information about the situation two years ago.

In May of 2018, however, an application for further modification of the facilities of W248CA was filed, File No. BPFT-20180517AEU. That application initially proposed a directional composite antenna which would operate with a center of radiation at 167 meters above ground level and with an ERP of 0.25 kW. Hall objected to that application because it gave every indication that it would return the translator to the operation which had initially created the significant interference issues. That situation has since been exacerbated by an amendment, submitted approximately June 5, 2019, which proposes a change to a nondirectional antenna and an ERP of 0.18 kW. While the power level has dropped somewhat, the change to a nondirectional antenna adds further potential for interference. Accordingly, Hall renews its objection to this application.

Attached hereto are Declarations of 28 regular listeners to WPCV, all of whom indicate that they listen to WPCV at least twice a month, have no legal, familial, employment, business or financial interest with WPCV, and identify specific locations in which they listen. *See*, Exhibit 1. Also attached is a Predicted Interference Study which indicates that the proposed facilities of W248CA will cause objectionable interference to these listeners, as the undesired to desired

signal strength exceeds -20 dB for all of these listeners. Id. The Predicted Interference Study also depicts the WPCV 45 dBu contour, the area of predicted interference, and the locations of the complainants, and it additionally indicates that the population within the WPCV is greater than 2,000,000. Id. While this population means that at least 25 complaints are required, the 28 which are attached more than meet that requirement. Additionally, a declaration of the WPCV chief engineer, attesting to the fact that WPCV is operating with licensed facilities is attached hereto as Exhibit 2.

Section 74.1204(f) of the Commission's Rules provides that a translator application will not be accepted for filing, and thus cannot be granted, if grant of the authorization will result in interference to the reception of a regularly used, off-the-air signal of any authorized co-channel broadcast station. 47 C.F.R. §74.1204(f). WPCV is such a co-channel station, as it is licensed to operate and does operate on Channel 248. As set forth above, Hall has met the requirements set out in Section 74.1204(f) for demonstrating that interference would be caused by W248CA's proposed facilities. Accordingly, W248CA's pending application must be dismissed.



Engineering Statement

This firm was retained to analyze an application for an FM translator W248CA.A to determine if the grant of this application would result in interference to the reception of co-channel WPVC(FM).

Per §74.1204(f) an application for an FM translator station will not be accepted for filing even though the proposed operation would not involve overlap of field strength contours with any other station, as set forth in paragraph (a) of this section, if grant of the authorization will result in interference to the reception of a regularly used off-the-air signal of any authorized co-channel, first, second, or third adjacent channel broadcast station, including previously authorized secondary service stations within the 45 dBu field strength contour of the desired station.

Within the protected contour of WPCV(FM) the population exceeds 2,000,000. Per §74.1204(f)(1) and using Table 1 to §74.1203(a)(3) the minimum number of listener complaints in this case is 25.

Per §74.1204(f)(2) a map "WPCV – Map of Listener Declarations vs Are of Interference based on FCC Contours (§73.313)" shows plots of the 45 dBu and 60 dBu field strength contour of the desired station WPCV(FM) and the 40 dBu interfering contour of W248CA.A. The intersection of the 45 dBu field strength contour of WPCV(FM) and the 40 dBu interfering contour of W248CA.A is shown as shaded in light green. Throughout the entirety of this shaded area the undesired to desired signal strength exceeds -20 dBu.

Per §74.1204(f)(3) WPCV(FM) is operating within its licensed parameters.

Per §74.1204(f)(4) WPCV(FM) has used commercially reasonable efforts to inform the relevant translator licensee of the claimed interference and attempted private resolution.

Per §74.1204(f)(5) within the area where the undesired to desired signal strength exceeds -20 dBu, a total of (28) listener declarations have been plotted. These locations are also identified by geographic coordinates by number and in table form. The intersection of the 45 dBu field strength contour of WPCV(FM) and the 40 dBu interfering contour of W248CA.A is shown as shaded in light green. Throughout the entirety of this shaded area the signal strength of WPCV(FM) is less than 60 dBu and the interfering contour of W248CA.A is greater than or equal to 40 dBu. Therefore, the signal strength of W248CA.A exceeds -20 dBu of the WPCV(FM) signal strength throughout the entirety of the shaded area.

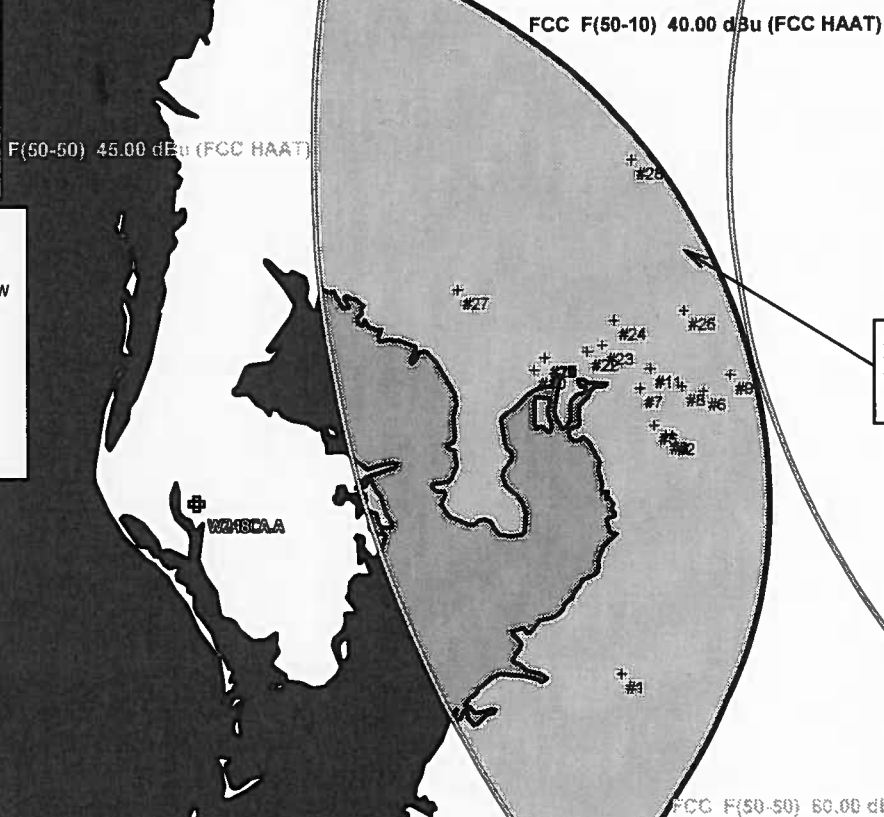
WPCV - Map of Listener Declarations vs Area of Interference based on FCC Contours (§73.313)
