

## **RADIO MARKET ANALYSIS**

### **MULTIPLE OWNERSHIP SHOWING ZIMMER RADIO, OF MID-MISSOURI, INC KZWV CHANNEL 270C2 – ELDON, MISSOURI MARCH 23, 2013**

This statement and attached exhibits were prepared on behalf of Zimmer Radio of Mid-Missouri, Inc. (“Zimmer”). Zimmer is filing an FCC Form 314 to acquire the license of KZWV Channel 270C2, Facility ID No. 165951, licensed to Eldon, Missouri and as such a demonstration of compliance with Section 73.3555 of the Commission's multiple ownership rules is needed. Zimmer is also the licensee of KSSZ(FM) Channel 230C3, Facility ID No. 5227, Fayette, MO, KATI(FM) Channel 232C2, Facility ID No. 67379, California, MO, KCMQ(FM), Channel 244C1, Facility ID No. 74583, Columbia, MO, KCLR-FM Channel 257C2, Facility ID No. 6014, Boonville, MO, KTGR-FM, Channel 263A, Facility ID No. 34408, Fulton, MO, KTXY(FM), Channel 295C, Facility ID No. 9929, Jefferson City, MO, KFAL(AM) 900 kHz, Facility ID No. 34409, Fulton, MO, KWOS(AM), 950 kHz, Facility ID No. 9927, Jefferson City, MO, and KTGR(AM), 1580 kHz, Facility ID No. 74584, Columbia, MO. KZWV is not located in any Arbitron metro county and is not listed as home to any Arbitron rated market. Therefore, a contour overlap study for stations not licensed to metro counties is necessary.

### **REVISED CONTOUR OVERLAP ANALYSIS**

Because KZWV is licensed to a non-metro county and not listed as home to any Arbitron Metro, a contour overlap analysis has been conducted for ownership compliance.

### **KZWV Defined Radio Market**

The combined city grade contours of KZWV Channel 270C2, Eldon, MO, KATI Channel

232C2, California, MO, KCMQ Channel 244C1, Columbia, MO, KCLR Channel 257C2, Boonville, MO, KTXY Channel 295C, Jefferson City, MO and KWOS 950 kHz, Jefferson City MO are being used create the Defined Radio Market Boundary. The contours used to create the Defined Radio Market Boundary are the FCC F(50,50) 70 dBu for FM stations and the 5.0 mV/M for AM stations. A total of 55 full power AM and FM stations with overlapping city grade contours including the six stations that make up the Radio Market Boundary determine the number of stations in the Defined Radio Market. No stations with transmitters more than 92 km from the boundary of the common overlap of subject stations will be considered. Further, no other facility of which the principle shareholders of Zimmer have an attributable interest will be considered as a market contributor unless it is a subject station in the radio market under study.

Exhibit One is a map showing the principal community contours of KZWV overlapping with the principal community contours of KCMQ, KATI, KCLR, KTXY and KWOS. These six subject stations make up the Defined Radio Market for KZWV.

Exhibit Two is a map showing non overlapping the principal community contours of KZWV with four commonly owned non-subject stations; KSSZ, KTGR-FM, KTGR-AM and KFAL. These four non-subject stations are not included in the total number of stations in the Defined Radio Market.



Exhibit Three is a map showing the Radio Market Boundary and all the full power AM and FM stations with overlapping contours. The Radio Market Boundary is clearly shown in black on the

map. A total of 59 stations are shown on the map. A total of 10 AM stations and 45 FM stations make up the Defined Radio Market for a total of 55 stations. This includes the six stations that comprise the Radio Market Boundary and 49 other AM and FM stations. This does not include four stations; two AM stations and two FM stations attributable to Zimmer that are not subject stations.

Exhibit Four is a tabulation of the stations in Defined Radio Market titled “Table of Contours Shown”. The number of stations depicted falls in the 45 or greater stations level. Therefore, common ownership or control of up to eight full power stations with no more than five in the same band is permissible. Zimmer owns or has interest in five FM stations and one AM station in the Defined Radio Market. Based on the review of the Defined Radio Market, it is believed that the proposed license transfer of KZWV to Zimmer is in compliance with §73.3555 of the rules.




contours.)





stations.


