ARTICLES OF INCORPORATION
of
DUO Ministries

A Nebraska Nonprofit Corporation

We, the undersigned, being persons of the age of twenty-one years or more, pursuant to the Nebraska Nonprofit Corporation Act, do hereby adopt the following Articles of Incorporation.

ARTICLE - I

Name

The name of this Corporation shall be DUO Ministries (“Corporation”). This Corporation is a religious corporation.

ARTICLE - II

Duration

The Corporation shall have perpetual existence.

ARTICLE - III

Organization Purpose and Powers

The purposes for which the Corporation is organized are:

3.1 To possess and exercise all powers conferred by the law of Nebraska upon corporations under the Nebraska Nonprofit Corporation Act, Neb. Rev. Stat. §21-1901 et seq. which an organization that is exempt under Section 501(c)(3) of the Internal Revenue Code of 1986 (“501(c)(3) IRC”), and the regulations thereunder, as amended or as hereafter amended, may possess and exercise.

3.2 Notwithstanding any of the powers under the Nebraska Nonprofit Corporation Act, Neb. Rev. Stat. §21-1901 et seq., the Corporation is organized and will be operated exclusively for the charitable, religious, and educational purposes within the meaning of 501(c)(3) IRC.

3.3 The Corporation shall also have the power to indemnify its directors and officers as may be provided in the Bylaws.

ARTICLE - IV

Principal Place of Business- Initial Designated Office

The Corporation's principal place of business and Initial Designated Office in Nebraska is: 7343 Rachel Rd, Lincoln, NE 68516.

ARTICLE - V

Registered Office and Registered Agent

ARTICLE - VI

ARTICLE – VII

Membership

The Corporation shall not have members.

ARTICLE – VIII

Board of Directors

The number of directors constitution the Board of Directors of the Corporation shall be set forth in the Bylaws. The number, qualifications and term of office of directors may be changed from time to time as provided in said Bylaws.

ARTICLE – IX

Dissolution

Upon the dissolution of the Corporation or the winding up of its affairs, the assets of the Corporation shall be distributed exclusively to any charitable, educational, or religious organizations in Nebraska which would then qualify under the provisions of 501(c)(3) IRC and its regulations as it now exists or as they may hereafter be amended.


ARTICLE – X

Amendments


These Articles may be amended only upon the affirmative of a majority in interest of the Board of Directors of the Corporation.
