



### ENGINEERING STATEMENT



The data contained in this report describes technical work performed on the AM Radiator of station WSCO, Appleton Wisconsin relative to the new installation of an FM Translator antenna and RF transmission line facility upon this existing radiator, for translator call sign W268AF. This new installation employs the 1/4 – wave stub method of decoupling the FM system across the tower base insulator, as is detailed in the attached sketch. A Radio Frequency Operating Impedance Bridge was employed at the tower base series-feed point while a steelworker adjusted the position of the stub shorting point, located approximately 90 electrical degrees above the tower base. A point was found which resulted in no disturbance of the original Antenna Resistance value. Accordingly, the WSCO stated Antenna Base Resistance remains unchanged from its present Instrument of Authorization.






