PETITION FOR RECONSIDERATION

South Valley Peace Center (SVPC) hereby seek reconsideration of the dismissal of its application, referenced above.

By letter, dated October 9, 2009, the Audio Division, Media Bureau dismissed this application due to prohibited overlap with short-spaced station KONND (FM), Clovis, CA, and a failure to formally request processing pursuant to 47 CFR §73.215 with respect to KONND, and with respect to KPSL-FM, Bakersfield, CA.

Concurrently with this Petition, SVPC is filing a curative amendment. The amendment proposes using a modified directional antenna, which will provide full contour protection to both KONND (FM) and KPSL-FM. The amendment also formally requests processing pursuant to §72.215, in Section VII, Item 15(d) of the application, and also in the application narrative. No other technical changes are proposed.

With the amendment, SVPC is in full compliance with all applicable contour protection and spacing Rules. Accordingly, SVPC hereby requests that the Commission grant this Petition for Reconsideration and reinstate the above referenced application, as amended, *nunc pro tunc*.

This letter is in reference to the above-captioned application for a new noncommercial educational FM station to serve Tulare, California on Channel 220B1.

An engineering study reveals that the facility proposed in the application fails to meet the minimum spacing requirements of 47 C.F.R. § 73.207. Specifically, the facility is short-spaced to the licensed facility (BLH-19970714KA) of first-adjacent channel Station KPSL-FM, Bakersfield, California on Channel 221A and the licensed facility (BLH-20010821AAG) of first-adjacent channel Station KOND(FM), Clovis, California on Channel 221B. These short-spacings were recognized in Exhibit 16 of the application, however, processing pursuant to 47 C.F.R. § 73.215 was not formally requested in Section VII, Item 15(d) of the application. Even had processing pursuant to § 73.215 been requested, our study shows that the application is in violation of the contour overlap provisions of that rule with respect to KOND. Specifically, the proposed 48 dBu interfering contour would overlap KOND's 54 dBu protected contour.¹ These deficiencies constitute acceptance defects.

In light of the above, Application BNPED-20071022ANE is unacceptable for filing pursuant to 47 C.F.R. § 73.3566(a) and IS HEREBY DISMISSED. This action is taken pursuant to 47 C.F.R. § 0.283.
